

Says Sircar

Speaker Jamiruddin Sircar yesterday said it is undemocratic for an elected government to pass power to unelected representatives on dissolution of parliament.

4 DU students appeal against conviction

Four Dhaka University (DU) students, who were convicted of violating the Emergency Power Rules (EPR) on the campus August 21-23 last year, filed separate appeals with the Metropolitan Sessions Judge's Court yesterday challenging their convictions.

Meantime, the case filed against seven DU students for torching an army vehicle and assaulting an army man at Shahbagh intersection during the DU violence on August 23 last year was transferred to a court for its trial.

ACC sues Shahida Obaid and 12 senior ex- officials

The Anti-Corruption Commission (ACC) yesterday filed a case against 13 senior ex-officials of the Secondary and Higher Secondary Education Board, Dhaka, including its former chairman, secretary, controller, deputy controller and assistant controller, for misappropriation of about Tk 24.37 lakh.

ACC Assistant Director Abu Bakar Siddique filed the first information report (FIR) with Lalbagh Police Station against former Dhaka Board chairman Shahida Obaid, secretary Harun ur Rashid, controller Farhad Hossain, deputy controller Nazmul Haq, assistant controller Abdur Rahman, CBA leader Golam Rasul and seven others for misappropriation of Tk about 24.37 lakh in the name of

development of workers' union. The case was filed under sections 109 and 409 of the penal code and section 5(2) of the Corruption

Prevention Act, 1947. Shahida Obaid, wife of late BNP leader KM Obaidur Rahman, told The Daily Star over phone last night, "The case is baseless and false. We have all the documents with us. Filing a Tk 23 lakh case against 13 people is ridiculous and it's been done only to tarnish my image."

WOMEN POLICY BEING USED

Radicals out to thwart war criminal trial move

Fundamentalists have made the National Women Development Policy 2008 an issue in a bid to suppress the public demand for trial of war criminals, participants at a roundtable yesterday said.

They also criticised the interim government for their silence on the street programmes fundamental groups carried out against the government's woman policy, issues of education, culture and clearly violating the state of emer- woman's empowerment,

Political leaders, NGO activists, women leaders and present and former advisers took part in the discussion on "Women in politics: in party, parliament and government", organised by Bangladesh Mohila Parishad and Saptahik 2000 magazine at the National Press Ayesha Khanam moderated the discussion while Kazi Sufia Akhter

presented the keynote paper. Rasheda K Chowdhury, women and children affairs adviser to the government, said fundamentalism is spreading alarmingly in the society and it is hard to imagine how far it would go in the future if proper attention is not given to the

Stressing the need for consensus on women's issues, she said women's advancement is not possible if the mainstream progressive forces do not get united.

The adviser called on politicians to create a friendly atmosphere for women so that they could come to leadership level.

Taking part in the discussion. Mohila Parishad president Awami League (AL) presidium member Tofail Ahmed said while sector commanders of the liberation war were not allowed to hold their national convention in a hall room, the government is silent on the processions that fundamentalist groups brought out in the street in opposition to the woman policy.

"It'll not be good if people raise questions on the present government's neutrality when it comes to fundamentalism," he warned.

Abdur Razzak, another AI presidium member, said religious issues are brought to the forefront whenever women's issues get prominence. "The fundamentalists violated the state of emergency but no action has been taken against them," he said.

Pak court meets amid looming showdown over judges

Pakistan's top court met yesterday amid a looming showdown between the country's new parliament and President Pervez Musharraf over his sacking of dozens of judges last year.

Meanwhile the party of slain former prime minister Benazir Bhutto set to lead Pakistan's coalition government nominated a woman MP to contest for the office of national assembly speaker, officials said.

Fahmida Mirza, 52, is now all but certain to win the top post in the 342-seat lower house of parliament, which will hold the election for the post on Wednesday.

Mirza, a seasoned politician from Benazir 's home province of Sindh, would be the first woman

speaker of the parliament in the 60year history of this deeply conservative Islamic nation of 160 million people.

Supreme Court Chief Justice Abdul Hameed Dogar, appointed by Musharraf to replace the president's arch-foe Iftikhar Muhammad Chaudhry, was due to chair the rare, full meeting of the court's 15 judges.

No agenda has been announced for the court's extraordinary meeting, which comes one day after the parliament dominated by Musharraf's opponents convened for the first time following last month's election.
