ALthreatens agitation if Hasina not released

Key leaders of Awami League (AL) yesterday threatened to go on a massive agitation programme if party chief Sheikh Hasina is not released immediately.

The AL leaders directed party leaders and workers at all levels to remain prepared for such a programme.

AL Presidium member Abdur Razzak warned that if Sheikh Hasina is not released then the party will be compelled to declare such a programme that will make it impossible for the caretaker government to remain in power.

Razzak was speaking at a mass hunger strike programme organised by Jubo Mohila League (JML) on Bangabandhu Avenue in the capital.

Hundreds evicted from Paribagh, Begunbari slums

The Bangabandhu Sheikh Mujib Medical University (BSMMU) authorities yesterday retrieved 2.14 acres of its land by evicting over 900 families from the encroached land known as Paribagh slum.

Meanwhile, the Rajdhani Unnayan Kartripakkha (Rajuk) demolished over 600 shanties at the Begunbari slum.

Around 100 forth class employees of BSMMU illegally constructed about 450 shanties on the land and had been collecting rentals from the 900 families.

ADP to be cut by 15 percent

Tk 15cr to be spent on livelihoods in 10 districts

The government is going to slash its annual development expenditure by 15 percent, while allocating an additional Tk 15 crore for programmes to develop the livelihoods of the people of 10 districts, Dinajpur, Gaibandha, identified as lagging behind in reducing the rate of poverty.

With a reduction of Tk 4,000 crore in the annual development programme (ADP) fund, the revised allocation for it will stand at Tk 22,500 crore.

The revised ADP and the new allocation for the 10 lagging behind districts' development are scheduled to be placed at a general meeting of the National Economic Council for approval today.

Sources in the planning ministry said based on a survey on household expenditures carried out by the Bangladesh Bureau of Statistics (BBS), the government selected the districts of Rangpur, Mymensingh, Jamalpur, Khulna, Bagerhat, Patuakhali, Pirojpur, and Bandarban for its district development programme.

Through implementing the programme, the government intends to minimize developmental discrimination based on geographical locations, said ministry sources adding that allocations for the programme is likely to increase more in the next budget.

Under the Tk 15 crore development programme for the 10 districts, the government plans to generate employment opportunities for the poor, especially the ultra poor, the sources said.

The rate of ADP project implementation in the current fiscal has been the most dismal ever, with only 25 percent of the projects been implemented in the first seven months of the fiscal 2007--'08.

The low implementation rate forced the government to cut the ADP budget down to Tk 22,500 crore from its original allocation of Tk26,500 crore.
