#### Mahathir urges PM Abdullah to resign

Veteran ex-leader Mahathir Mohamad on Tuesday urged Malaysian Prime Minister Abdullah Ahmad Badawi to resign following disastrous election results.

Abdullah, also president of the ruling United Malays National Organisation (UMNO), is facing increasing calls to quit from party leaders.

"I ask (Abdullah) to resign," the former prime minister, who ruled Malaysia for 22 years, told a gathering of at least 2,000 UMNO members.

The focus of the meeting was to analyse the March 8 election results but it turned out to be a platform to demand Abdullah's resignation.

#### 'Immigrants putting strain on Britain'

Record levels of immigrants are putting too much strain on British public services and the government has overstated their positive economic impact, a parliamentary report said Tuesday.

The inquiry by a House of Lords committee including two former finance ministers concluded that a surge in immigration since the post-2004 expansion of the European Union had led to "little or no impact" on economic well-being.

Bush support for Ukraine's Britain to Nato entry opens up alliance split

President George W Bush said yesterday the United States "strongly supports" Ukraine's bid to join Nato at the summit, which opens in and told Russia it would have no BucharestonWednesday. right to veto the move.

at the annual Nato summit in Bucharest this week, France opposed letting Ukraine and Georgia into the alliance, with Prime Minister François Fillon saying it could upset the balance of power in Europe.

Kiev, Bush said Washington wanted to see Ukraine and Georgia, both former Soviet republics, given a Membership Action Plan (MAP), a formal step toward joining Nato.

"I strongly believe that Ukraine and Georgia should be given MAP and there's no trade-offs, period," said Bush, with Ukrainian President ViktorYushchenko at his side.

The US president however stopped short of saying that the Atlantic alliance must extend MAP agreements to Ukraine and Georgia

Bush's comments were likely to But in a sign of protracted debate stoke tension with Russia and the membership move is opposed by Germany, France and other European powers.

"We are opposed to the entry of Georgia and Ukraine because we think that it is not a good answer to the balance of power within Europe Speaking at a news conference in and between Europe and Russia," the French prime minister said in an interview with France Interradio. "France has a different view from

Britain is to announce Tuesday that there are no current plans to reduce troop levels in southern Iraq, following a recent flare-up around Basra, reports said.

Prime Minister Gordon Brown announced in parliament last October that Britain hoped to reduce troop levels from 4,100 to 2,500 in the spring but media said that has been called into question

Defence Secretary Des Browne is to make a statement on Iraq in the House of Commons at 3:30 pm (1430 GMT), the Ministry of Defence confirmed, but declined to comment on the reported announcement.

The BBC reported he would say that there are no current plans to cut troops in Iraq, while the Guardian daily said on its website that Browne was expected to "abandon plans" to cut the number of British troops in Iraq.



### Truce calms Iraq, weakens PM Maliki

Rockets fell on the Green Zone and random machine gun fire rang out Monday in the southern city of Basra as Shia cleric Muqtada al-Sadr sought to rein in his militia after a week of battles that claimed about 400 lives.

The peace deal between al-Sadr and Iraqi government forces said to have been brokered in Iran calmed the violence but left the cleric's Mahdi Army intact and Iraq's US-backed prime minister politically battered and humbled

In spiralling pre-poll violence in Nepal, scores of people were injured in fresh clashes between cadres of Nepali Congress and Left parties, prompting a worried Election Commission to urge parties to refrain from activities that will affect the credibility of the

Curfew was clamped in Dadeldhura district in far west Nepal after Maoists and CPN-UML activists allegedly beat up Nepali Congress workers during canvassing on Monday for the April 10 Constituent Assembly polls. The cadres of the two Left par-

ties attacked the Nepali Congress district office accusing its workers of burning their party flags. Over two-dozen people were injured in the violence.

In another incident, a central member of People's Front Nepal Kaman Singh Lama was seriously injured when cadres of CPN-

United attacked him during campaigning in Kaver district.

With the feud among the parties spilling on the streets, Chief Election Commissioner Bhoj Raj Pokharel met Prime Minister Girija P Koirala, Maoist chief Prachanda and CPN-UML leader Madhav Kumar Nepal urging them to take steps to stop the violence that could hamper canvassing.

"The violence, including killings, beatings and the threatening of election candidates has occurred in several parts of the country and the trend is increasing... We are worried," Chief Election Commission Bhojraj Pokhrel said.

"This will spoil the election environment.... It will raise questions over the elections being credible and fair," he told reporters.

Urging all parties to exercise restraint and control their cadres, Koirala said the EC had the authority to mobilise Nepal Army, police and civil servants if needed.
