'Charge against Ariful, wife based on documents'

The Anti-Corruption Commission (ACC) case against detained Sylhet city BNP chief Ariful Haque Chowdhury and his wife Shama Haque Chowdhury was filed after investigation found that they possessed assets and property beyond their known sources of income.

This was stated by ACC Deputy Director Md. Nasir Uddin in his deposition before the court of District and Sessions Judge Md.

Abdul Gafur yesterday. Deposition in the ACC case against Ariful and his wife began in the court on Sunday. Md. Nasir Uddin, DD of ACC's Sylhet regional office, is also the complainant of the

The court on April 22 framed charges in the case. Ariful was a close aide to former finance minister and BNP stalwart M Saifur Rahman.

There are 27 witnesses including the complainant in the case, court sources said. The ACC DD told the court that specific charges based on documents were made against the accused for accumulating property

The ACC filed charge sheet against Ariful and his wife Shama for accumulating wealth worth over Tk 2.5

crore through corruption. ACC Assistant Director in Comilla regional office Shahin Ara Momtaj filed charge sheet in the case with the Chief Judicial Magistrate court in

Sylheton March 3. Ariful also faces another case for hiding wealth worth about Tk 1.5 crore in his statement submitted to

ACC earlier, sources said. Ariful was on the first list of corruption suspects, announced by the ACC. Absconding for weeks after the 1/11, Arif surrendered at joint forces camp at Sylhet Stadium on February 25 last year.

Soon after, several extortion cases were filed against him. Ariful is also a ward commissioner of Sylhet City Corporation (SCC). He was also chief of the development sub-committee

The school runs with all doors and windows closed. Inside classrooms, janaza was held at central Eidgah children often cough as they feel suffocated due to smoke and stink coming from an adjoining brickfield. The brickfield is only about 30 feet from Samannopur Primary School

in Santhia upazila in the district. "Heavy smoke billowing from the brick field at times blurs visibility on the (school) compound", its headmaster Md. Nazimuddin said while

talking to this correspondent during a visit this week. "We take classes shutting doors and windows", he said.

The Mollah Brick Field owned by Md. Siddik Ali was set up in 2004. A road divides the school compound and the brick field. The primary school is in Santhia upazila and the brick field is in adjoin-

ing Sujanager upazila. "Some of the children often suffer from allergy. Often the air is stinky as soyabean waste is burnt in the brick field as fuel. Dust also causes suffer-

ings," the headmaster said. "We also informed the upazila administration but nothing has been done" the headmaster said.

Contact, Santhia Uupazila Nirbahi Officer (UNO) Akbar Ali said, "I sent a report to the district administration suggesting steps for the sake of

But brick field owner Siddik Ali said, "I got permission from the authorities through legal ways", he said.

KCC executive engr held in graft case

Police yesterday arrested executive engineer of Water Works Department of Khulna City Corporation (KCC), Md Abdul Hannan, from Khulna Metropolitan Police (KMP) headquarters.

The arrested KCC engineer is one of the 13 accused in a case filed on April 20 for misappropriation of Tk 10 crore filed with Khulna Sadar Police Station.

The procurement officer of KCC's Municipal Services Project (MSP), SM Hafizur Rahman, who was suspended on charge of corruption in September last year, filed the case against detained city mayor Sheikh Tayebur Rahman, his wife Laila Rahman and eleven others accusing them of misappropriating Tk 10 crore in the name of purchasing chlorine gas required for water purification.

Sub-inspector Azfaruzzaman of Khulna Sadar Police Station who is investigating the case, said the executive engineer was arrested on the basis of evidence to prove his involvement in the misappropria-

The arrested executive engineer was arrested when he went to KMP headquarters to talk with the police commissioner about solution of a
