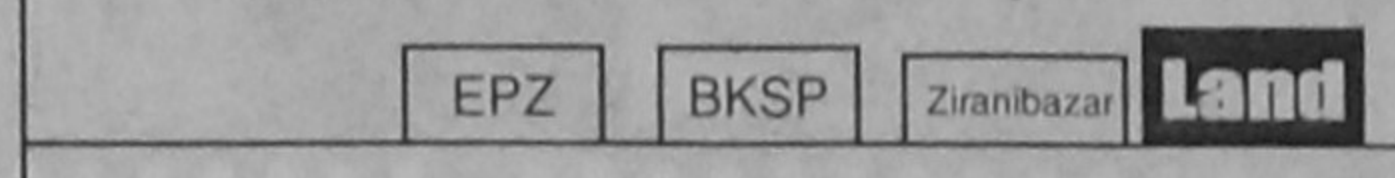


Mr. Iftekharul Alam appointed as the Chairman of Dhaka Public College.
