# 'Criminals' back on must be smooth scene with hope of running in polls

STAR REPORT

Many grassroots level political leaders of major parties including incumbent ward commissioners, who were allegedly involved in criminal activities, are preparing to contest in the August 4 polls to four city corporations.

Many of them already collected application forms for candidacy, although all major political parties have yet to announce their acquiescence to the local government polls before the parliamentary one.

A total of 921 persons picked up application forms for candidacies in the polls to the city corporations of Rajshahi, Khulna, Barisal and Sylhet till yesterday, for the posts of mayors and councillors including the reserved seats for women.

Most of the incumbent ward commissioners of the city corporations who were absconding since

promulgated on January 11 last ment properties. year, are back in their areas with door-to-door electoral campaigns already, even before selections.

Barisal at least 10 incumbent commissioners, most of whom are involved in BNP politics and were absconding to avoid arrest on charges of involvement in criminal activities, are back in their wards campaigning unofficially for votes. The scenarios are the same in

Sylhet and Rajshahi. Out of the 921 application forms 165 were distributed in Rajshahi, while 11 in Khulna, 516 in Barisal, and 129 in Sylhet were distributed.

Sources said some of the commissioners, under whose names forms were picked up, had earlier surrendered to courts and after getting released on bail are now planning to contest in the city corporation poll, to which end they already started campaigning.

Commissioners who are already on campaign trails with their criminal records still effective include Ziauddin Sikder, commissioner of ward no 25 who was absconding for a long time, and Firoj Ahmed, commissioner of ward no 24 who was arrested by the joint forces and is currently being tried in three

# Political transition to save economy

Says WB vice president

The World Bank (WB) yesterday said Bangladesh's economy would be affected unless a smooth political transition takes place through election, but it would continue to support the country's developmentagendas.

"If the political transition does not happen as predicted, any uncertainty is going to affect the economy, private sector and investor confidence," said Praful Patel, WB vice-president for South Asia.

Patel was speaking at a press conference yesterday at the end of his two-day visit to Dhaka.

During his visit, Patel met with Chief Adviser Fakhruddin Ahmed and other advisers to discuss the government's wide-ranging governance and economic policy reform agendas including holding of a general election.

The WB official also met with the Chief of Army Staff General Moeen U Ahmed.

"A smooth political transition would be good for all," he said, adding that everybody would



prefer not to go back to the pre-1/11 situation.

Referring to his talks with the "key players" of the caretaker government, Patel said the electoral roadmap is on track as voter registration and reforms in election rules by the Election Commission have been put in place for a better election.

"We are in the business of continuing our support to developmental agenda of Bangladesh. We did it before. We did it during the

# PDB to face Tk 112cr loss a month

The monthly loss of Power Development Board (PDB) will shoot up to Tk 112 crore from the present Tk 70 crore when it starts purchasing 300MW power from eight rental power plants.

In the light of this loss increase, the PDB submitted a proposal to the Energy Regulatory previous fiscal year. Commission (ERC) last month to But PDB's average billing is Tk enhance the present power tariff by 41 percent, which, if done, will help it reach a break-even point.

"The ERC might adjust the tariff considering the economic realities of the country," said a top official of the PDB.

Side by side, the board is seeking subsidy from the finance ministry through the power ministry to offset the loss caused by the government-controlled low power sales tariff over a higher production rate, said a competent source.

The finance ministry is already giving the PDB a Tk 50 crore monthly loan to minimise the

impact of its losses. Entities like the Rural Electrification Board are making

subsidising their power purchase rates and swallowing the losses.

Legally set up like an autonomous body, all the major decisions of the PDB is actually controlled by the administration, which has deeply affected its financial health. The PDB earned Tk 5,200 crore

during the last fiscal year, which is 19 percent higher than that of the

2.37 per kilowatt-hour (or an unit) against an average supply cost of Tk 2.82 a unit, which forces it to incur a loss of 45 paisa per unit. The loss

totals up to Tk 70 crore a month now. When the eight rental power plants come into operation, the PDB will incur an additional loss of Tk 42 crore because of these plants'

high cost of per unit electricity.

Despite such loss projections, the government was willing to take the rental power only on the ground that seven of these would start generating power from May. "The cost of not having power is many times higher," said a top

power ministry official. However, six of these eight costly plants have miserably failed profits just because the PDB is to meet the launching deadline of

May 15 as three of the contractors, which were awarded seven of these projects by the Power Cell, are inexperienced.

Only Aggreko, a real rental power company of the UK, started pumping 40MW power from Khulna to the national grid from early this month. Aggreko was supposed to launch operation from May 28 but started it from June 4. The oil-fired plant was officially inaugurated on Monday.

On January 15, the Power Cell awarded four contracts to Energy Prima, a shell company of Hosaf Group. Owned by Moazzem Hossain, brother of former BNP lawmaker Mosharraf Hossain from Feni, Energy Prima claimed that it had partnership with a Russian company. But that Russian company never appeared in the field. Sources said accused of corruption in a graft case filed by the Anti-Corruption Commission, Moazzem bagged the deal using his political connections.

Failing to run its power plant from May 15, Energy Prima promised to launch its 50MW Kumargaon plant in late May,

Detained former home minister Mohammad Nasim was admitted to city's Labaid Specialised Hospital (LSH) yesterday, after suffering a stroke.

He is not out of danger until 72 hours pass by, the hospital authorities said adding that the left side of Nasim's body has become 'weak'

However, the medical board and the hospital authorities refused to disclose anything about the report. Mohammad Nasim, who had

leader was rushed to Bangabandhu Sheikh Mujib Medical University (BSMMU) Hospital at first, but due to seat crisis, he was admitted to Labaid at about 12:30pm in an unconscious state, Shamsul Haider



At a press briefing at the hospital conference room at about 5:00pm, the LSH authorities told reporters that Nasim suffered brain stroke, which they term 'Hemorrhagic stroke.'

"His [Nasim] left side became weak, not paralysed, and he is conscious and oriented," Maj (retd) Dr AKM Mahbubul Hoque, co-ordinator and head of medical services, LSH, said.

"He is undergoing 'conservative treatment'," Dr Mahbub said adding that it cannot be said if the AL leader is out of danger before 72 hours have passed. Replying a query, Dr Mahbub

said that the patient's treatment can be continued here if his condition does not deteriorate further. SEE PAGE 15 COL 3

#### Turbulent Jamuna causes massive erosion

River erosion has taken a turn for the worse in five upazilas of Sirajganj on the western bank of the Jamuna devouring large areas and making people homeless.

The erosion devoured around 450 homesteads and 270 acres of cropland in the last seven days and rising water inundated many lowlaying char areas.

Many people of the area have moved to safer places like roads, higher lands, embankments and in different educational institutions.

The affected areas are Jogtola, Kaizuri, Jamirta, Benotia, Porzona, Bagporzona, Gudhibari and Daya in Shahzadpur upazila, Maizbari, Shubhogachha, Natuarpara, Meghai, Bilchetol, Khudbandhi and Baoikhola in Kazipur upazila, Char Mesra, Kawakhola and Gutibari in Sirajganj Sadar upazila, Char Delua and Operchar in Belkuchi upazila, Enayetpur, Sthal, Umorpur, Char Umorpur, Jalalpur and Billahchar in Chowhali

The erosion has put several hundred structures and establishments including schools, colleges, madrasas and bazaars under threat, sources said.

Natuarpara High School in its bid to reduce losses in river erosion recently sold a two-storied building of the school for Tk 7.21 lakh in an auction. The Natuarpara Degree College is also under threat, Water Development Board (WDB) sources said.

## Khaleda to endorse 4-party decision on local polls

Detained BNP Chairperson Khaleda Zia yesterday said she would go by whatever decision the four-party alliance should take regarding the local elections scheduled for August 4.

Queried whether BNP would boycott the polls, she said, "Our secretary general has already talked about this and I would comply with decisions of the four-party alliance."

A day before the Election Commission (EC) announced schedules for polls to four city corporations and nine municipalities, BNP Secretary General Khandaker Delwar Hossain said the four-party alliance would resist the elections.

Speaking to the newsmen after hearing on charge framing in Gatco graft case at a special court, the former prime minister also reiterated her call for holding the parliamentary election before any other

She said, "All major political

parties want the national election first. Besides, the present govern ment has no mandate to hold local government polls."

Earlier, Judge Shahed Noor Uddin of Special Court-3 set June 30 for the next hearing on charge framing in the high-profile graft case against Khaleda and 23 others including her younger son Arafat Rahman Koko.

The BNP chief was produced before the court on the Jatiya Sangsad Bhaban premises at 10:32am. She said the local elections must be held under an elected govern-

ment. The interim administration

should rather concentrate on preparations for the national election as not much time is left. She observed that corruption has increased during the present regime that took power by promis-

ing to curb the menace.

"They have failed in every aspect and should quit without delay," she added. SEE PAGE 15 COL 4
