





ANNOUNCEMENT OF VACANCIES International Labour Organisation (ILO) - Country Office Dhaka

ILO, a specialized agency of the UN, is seeking applications from qualified professionals for one of its programmes entitled "Technical and Vocational Education & Training (TVET) Reform Project'. A team of six International Experts will head the Programme and the following national professionals will be recruited for the programme:

- Program Officer on TVET Policy, Systems & Management (Component 1) 1 position.
- Program Officer on TVET Quality & Relevance (Component 2) 1 position.
- Program Officer on TVET Institutions Management & Teacher Training (Component 3) 1 position.
- Program Officer on Workplace Learning & Productivity Improvement (Component 4) 1 position.

Program Officer on Skills Training for the Underprivileged (Component 5) - 1 position.

There are five components to the project: (1) TVET policies, systems and legislation reviewed and strengthened at the central and decentralized levels; (2) Enhanced flexibility, quality and relevance of TVET; (3) Strengthened TVET institutions through improved knowledge and skills of managers and teachers; (4) Improved skills development resulting in enhanced productivity and competitiveness in key growth and export-oriented industries in the formal industrial sector, and (5) Increased access of underprivileged groups to TVET.

More detail on the scope of Component activities are included in the terms of reference for each position. The main tasks for each position are common and are shown below.

PROGRAMME OFFICER MAIN TASKS

- 1. Review and analyse country and sector specific TVET plans and policy documents, socioeconomic data, reports and other relevant information;
- Strengthen implementation of the TVET Reform Project through the provision of technical advice regarding the design, implementation, monitoring and evaluation of Component activities;
- Assist the international expert for Component to monitor progress of Component activities by reviewing, verifying and analysing progress reports, final reports and other data for clarity, consistency and completeness;
- Follow-up with relevant departments at headquarters and regional office, executing agencies, government offices, industry, training organisations and other organizations to expedite implementation and meet targets for Component activities;
- Provide programming and administrative support to programmes and projects in Component;
- Prepare briefs, periodical reports and statistical data on status of Component activities; Assemble and edit basic data required for planning and negotiation of Component activities;
- Follow-up on delayed documents, clarify information, and answer questions about clearance and processing requirements;
- 9. Assist in the programming and control of Component resources, prepare activity budget estimates and expenditure forecasts;
- 10. Assist in the development and maintenance of computerized information systems for use in monitoring and reporting on activities and performance;
- 11. Participate in the organization of conferences, seminars, workshops, training sessions and meetings;
- 12. Brief ILO specialists, project experts, associate experts and visiting officials and provide relevant information on Component matters;
- 13. Draft in, or translate into, local language(s) news releases, official correspondence, statements and speeches and other information material.
