The North-West Power Generation Company Ltd. (NWPGCL) owned by the BPDB and a successor utility for generation of electricity to meet the growing demand of BPDB's system, has already started functioning. Now the NWPGCL invites applications from qualified professionals for the following posts.

1. Managing Director: (01)

The Managing Director is the Chief Executive Officer of the Company reporting to the Board of Directors. He is the leader of the Management Team of the Company, responsible for overall management, e.g. administration, corporate planning, business development and ensuring the compliances of Laws, Rules and Regulations and for Good Governance, including development of set-up, rules, regulations and systems and legal functions of the organization. He is also responsible for supervision of all technical, financial & welfare aspects, negotiation for project financing issues with donors/development partners and listing the company in the stock exchange(s) etc.

Qualification of the Candidate:

Academic qualification of the candidate shall be Graduate/MSC in Engineering, preferably having Electrical/Mechanical Discipline. The candidate having Post Graduate in Management, Social Science, Physical Science, Applied Science, Finance, Accounting or FCA/FCMA/MBA. Degree with long time managerial background in any large organization (Govt./Semi-govt./Autonomous/Private) may also apply. The candidate should be fluent in spoken and written Bangla and English language and shall be capable of working under and managing the emergency situations.
