The High Court (HC) yesterday asked the Anti-Corruption Commission (ACC) to submit the Gatco corruption case docket (records) before it by tomorrow for examination.

The case was filed against detained former prime minister Khaleda Zia and 22 others on September 2 last year in connection with corruption in awarding Global Agro Trade (Pvt) Co Ltd (Gatco) the contract for container management at inland container depots in Dhaka and Chittagong causing a loss of over Tk 1,000 crore to the state exchequer.

With the new system in place, not only are the IOs under supervision but the supervising officers of the cases will also be held responsible for any flaws in investigation, top DMP officials said.

The DMP has also directed DCs to check on cases pending investi-

The commissioner said that to put a stop to unnecessary harassment of people, DMP has issued a directive that an IO must visit the crime scene within 24 hours of an incident. The IO must also file the primary case diary within 48 hours

A top DMP official seeking anonymity said that this has been done to prevent the IO of a case from amending the facts of the primary case diary later on.

The Discipline Department of the DMP has also been asked to be more active about any negligence during investigations or any unauthorised arrests. The department has taken punitive actions against around 400 policemen since last month.

The DMP commissioner said that they have also introduced a mechanism to evaluate the performance of police stations and its case investigation officers.

"Through this daily evaluation sheet, I can keep an eye on how many crime incidents take place each day, and even the development of investigations into each of those," the commissioner said.

JAIL KILLING CASE HC hearing of appeals against verdict starts

Four years after the trial court's delivery of judgment, hearing of appeals and death references against the verdict in the 1975 Jail Killing Case began in the High Court (HC) yesterday.

On the first day of the hearing, barrister Abdullah-al Mamun, counsel for the convicts, read out the paper book in the case before the HC bench comprising Justice Nazrul Islam Chowdhury and Justice Md Ataur Rahman Khan.

At the end of the day's proceed ings, the court fixed July 14, today, for the next hearing of appeals.

Acting president of the Bangladesh government-in-exile Syed Nazrul Islam, prime minister Tajuddin Ahmed, finance minister M Mansur Ali, and minister of home affairs, relief and rehabilitation AHM Qamaruzzaman, were killed inside Dhaka Central Jail on November 3 of 1975.

Then Metropolitan Sessions judge of Dhaka Court Mohammad Motiur Rahman delivered the verdict in the case on October 20 of 2004, sentencing three people to

24 killed in Afghan suicide blast

Bush asks Israel to prepare for possible strike on Iran

PTI, AFP, London/ Tehran

US President George W Bush has given Israel a go-ahead to begin preparations for a military attack on Iran, in case talks over the country's controversial nuclea programme fail to yield results, a media report has said.

The Bush administration is said to have informed Tel Aviv that he would back an Israeli plan to strike Iran's main nuclear sites with long range aerial weapons if diplomatic talks over Tehran's nuclea programme broke down, the Sunday Times said quoting a

Pentagon official. The American President has given Israel an "amber light" to start preparing for a possible offensive, the official told the Sunday

"Amber means get on with your preparations, stand by for immediate attack and tell us when you're ready," the official as quoted as saying to The Times.

The US President's voice of support comes despite his military officials' opposition to an attack on Iran, given the risks of an aerial strike. SEE PAGE 15 COL 8
