Electoral laws won't allow them time to reschedule bank loans before upcoming elections

Loan defaulters will not get any opportunity of becoming eligible to contest in the upcoming upazila and parliamentary polls by rescheduling their loans, although the new electoral laws allow them to become eligible by rescheduling the loans within specific timeframes before submissions of applications for candidacies.

Awami League president Sheikh Hasina yesterday filed a writ petition with the High Court (HC) challenging the legality of MiG-29

MIG-29 CASE Hasina challenges Bureaucracy reform move goes into hibernation

CA-led administrative reform committee could hold one meeting in a year

The caretaker government's move to infuse dynamism, accountability and transparency into the public administration has hardly seen any progress since the initiative was taken a year ago.

This has frustrated many including a few civil bureaucrats who have been in favour of reforms in the civil administration. They said like many other initiatives this

may also end up in rhetoric.

Formed in July last year with an objective of giving concrete directives for reforms in the administra-

tion and guidelines for posting and transfer, the chief adviser-led cabinet committee on administrative reforms and good governance has so far managed to hold just one meeting.

As the government is presently busy with holding dialogues with political parties and the upcoming local government and parliamentary elections, chances are slim that another meeting would be held in near future.

"I am not yet informed about another meeting of the committee," an adviser and a member of the committee told The Daily Star last week.

In December last year, the establishment ministry drafted a civil service ordinance and policies for promotion, transfer and career planning for public servants and strengthening the field administration, but those are gathering dust at

the ministry. Sources in the ministry said it is the government that would have to be more serious about the matter. A member of the administrative reforms committee, however, said the ministries concerned should

ACC allowed to quiz Khaleda, Tarique on fake orphanage

Koko asked to appear in court July 24 COURT CORRESPONDENT

A Dhaka court yesterday allowed the Anti-corruption Commission (ACC) to interrogate detained former premier Khaleda Zia and her elder son BNP Senior Joint Secretary General Tarique Rahman at the jail gate in connection with a corruption case.

The commission filed the case against seven people including Khaleda and Tarique on charges of embezzling over Tk 2.10 crore by forming a fake establishment named Zia Orphanage Trust.

Meantime, another Dhaka court yesterday asked the jail authorities to produce Khaleda's younger son Arafat Rahman Koko before it on July 24 in connection with a graft case, although he had been released on medical grounds for two months.

Govt ordinances salvaged

SC stays Muslim marriage rule, asks govt to file regular appeal within a month

The Supreme Court (SC) yesterday stayed for one month the High Court (HC) judgment that declared illegal and void the Muslim Marriage and Divorce (Registration) Amendment Ordinance 2008 promulgated by the president.

Upon a government petition, Chamber Judge of the Appellate Division Justice MA Matin passed the order, also asking the government to file a regular appeal with the SC against the HC verdict within this period.

The ordinance promulgated by the president empowers deputy (official marriage registrars).

Six kazis including Pirzada Syed Hazee Shariatullah, kazi of Moghbazar in Dhaka and president of Bangladesh Muslim Marriage Registration and Kazi Samity, on March 13 jointly filed a writ petition with the HC challenging the ordinance.

On July 13, the HC bench of Justice ABM Khairul Haque and Justice Md Abu Tariq declared the ordinance illegal and void, observing that the president had promulgated the ordinance beyond his constitutional jurisdiction.

The HC observed that during the rule of caretaker government the president cannot promulgate ordinances on issues not related to

"In Bangladesh, the president's powers are limited even during the tenure of elected governments and it is more limited during the carecommissioners to recruit kazis taker rule. The president can promulgate ordinances related to holding national elections. There is no such urgent situation in the country that the president should promulgate ordinances on other issues," the HC said.

Border talks begin in Kolkata today

BSF kills another Bangladeshi at Sadipur border

The border security forces of Bangladesh and India begin a fourday negotiation in Kolkata today amid persistent killings of Bangladeshis by Indian Border Security Force (BSF) that sparked military tension along the entire frontier area.

Five Bangladeshis, including two Bangladesh Rifles (BDR) jawans were killed by BSF since early Friday with the latest killing taking place at Benapole border tion. early yesterday.

Both sides deployed reinforcements at all frontier posts keeping their forces alert, while shooting and killing by BSF continued, worsening the already volatile border tension between the two neighbouring countries.

The deputy director general (DDG) level meet between BDR and BSF is expected to discuss the issue of killings at the borders as the BDR delegation will raise the latest incidents strongly, asking their counterpart for an explana-

Amassed staggering wealth through commission from purchase, maintenance, leasing jobs during BNP-led alliance rule

Shamim Iskander, a former flight engineer of Biman and brother of ex-prime minister Khaleda Zia, made a fortune taking commissions on lease and maintenance of aircraft and purchase of spare

parts, said airline sources. He is one of those blamed for the huge losses incurred by the national flag carrier that had almost gone bankrupt during the BNP-led four-party alliance rule, said several former and incumbent officials of Biman Bangladesh

Arrested by the joint forces on July 18, Shamim is listed by the Anti-Corruption Commission (ACC) as a graft suspect.

Talking to The Daily Star, some of his former colleagues in Biman said he would lead a life of luxury. He would use a platinum credit

card of UK-based Barclays Bank and ride a fancy SUV, which was seized by Dinajpur police in a corruption case on June 21. He owns a house each in Australia and Canada, they continued. The wealth statement he sub-

mitted to the ACC on June 10 last year shows that he and his wife have assets worth around Tk 4 crore and 75 tolas of gold. However, Biman sources said

Shamim made at least Tk 40 crore in commission on lease of three aircrafts for the airline during the tenure of alliance government. Biman had to pay at least Tk 250

crore for lease on the three aircraft when at least six such planes could have been bought with that amount, they added. He also had a role in having an

Airbus aircraft leased to Biman from the US. Riddled with defects, the plane cost Biman about Tk 100 crore in five years, whereas its current market price is about Tk 62.10 crore.

Besides, he made arrangements for a Boeing 747 to be leased to Biman, which was not necessary at SEE PAGE 15 COL 2

The High Court (HC) yesterday granted bail to former Awami League (AL) ministers Tofail Ahmed and Syeda Sajeda Chowdhury and former BNP minister MK Anwar in separate corruption cases filed by Anti-Corruption Commission (ACC).

Meanwhile, the Supreme Court (SC) stayed for a month the HC awarded bails to former BNP minister Tariqul Islam, former state minister for liberation war affairs Redwan Ahmed, his wife Momtaj Ahmed, Barisal City Corporation (BCC) Mayor Majibor Rahman Sarwar and Dhaka City Corporation (DC) Ward Commissioner Abdul Qaiyum in separate corruption cases.

The HC orders came after separate bail petitions were filed by Tofail, Sajeda and Anwar.
