Obama all praise for "miracle" of Israel

White House hopeful Barack Obama vowed yesterday to tighten US bonds with Israel as he began an intense day of talks with Israeli and Palestinian leaders, a key moment in his international campaign

Obama lauded the "miracle" of Israel as he met top officials and paid homage to Holocaust victims on the latest leg of his international campaign swing.

The Democratic senator, on a sprint through the Middle East and Europe designed to convince American voters of his presidential mettle, also travelled to the West Bank to consult Palestinian leaders Thursday. on sluggish peace moves.

He angered Palestinians last month by saying an undivided Jerusalem must remain Israel's "capital", while the Palestinians want the occupied eastern sector of the city as the capital of their promised future state.

Obama opened his day with talks with Israeli Defence Minister Ehud Barak, who was later set to join him on a helicopter tour of Israel's cramped topography, a rite of passage for potential US presidents.

He also toured Yad Vashem Holocaust memorial to the six million Jews who perished under the Nazis.

The memorial reminded him of "the core qualities of humanity that the Holocaust raises," he told reporters. "Man's great capacity for evil, and capacity to stop it. This is a place of hope."

Obama, who leads Republican rival John McCain in most opinion polls, also paid his respects to president Shimon Peres, saying he had been a key player for most of

'Afghanistan tougher job than Iraq'

Democratic presidential hopeful Barack Obama said Afghanistan might end up being tougher to subdue than Iraq, days after visiting both war zones.

The White House hopeful told Time magazine in an interview that his two trips had confirmed in his mind many of his earlier thoughts about future US policy towards the two countries.

"I think in Afghanistan, looking at the landscape and the extraordinary poverty involved, makes you realise what a daunting task our efforts there are going to be," Obama told Time.

"It redoubles my belief, or deepens my belief, that if we're going to get that done we're going to have put in more resources," he said in the interview posted on the maga-

Karadzic to defend himself

Radovan Karadzic, the Bosnian Serb genocide suspect who was captured earlier this week, will defend himself before the UN war crimes tribunal in The Hague, his lawyer was reported as saying

"Karadzic will have a legal team in Serbia that will help him with his defence but he will defend himself" at the International Criminal Tribunal for the former Yugoslavia (ICTY), Tanjug news agency quoted Svetozar Vujacic as saying.

Karadzic, who stands indicted for genocide and crimes against humanity, was arrested in Belgrade on Monday after more than a decade on the run. He evaded capture partly thanks to a fake identity as an alternative health

Earlier, Vujacic said that he would file an appeal against being sent to the UN tribunal based in The Hague on Friday, in a bid to postpone the transfer for as long as possible.

Under Serbia's law on cooperation with the ICTY, suspects can appeal their transfer to the UN war crimes court before a special committee approves the transfer.

The process could take up to nine days, but Serbia's war crimes prosecutor has said it expects Karadzic -- nicknamed the Butcher of Bosnia for his actions -- to be sent to the UN court by Monday or Tuesday at the latest.

Meanwhile arrested genocide suspect Radovan Karadzic fought his transfer to the UN war crimes tribunal yesterday, as his Bosnianbased family sought the return of seized travel papers in order to visit

Karadzic, the nationalist wartime Bosnian Serb leader who remained at large for more than 10 years despite an international manhunt, was captured on Monday night.

To avoid detection, Karadzio had practised alternative medicine under a false name, Dragan Dabic, and made himself virtually unrecognisable.

He disguised himself under flowing white hair, a thick beard, glasses and a white Panama hat, even appearing on television and drinking at cafes in downtown Belgrade with naturopaths to convince them of his new identity.

One Serbian daily described the look as that of a "Loveable Guru".

Under Serbia's law on coopera tion with the war crimes tribunal, suspects can appeal their transfer to the ICTY before a special committee approves the transfer.

Iraq set for assault on al-Qaeda bastion

Some 30,000 Iraqi soldiers and police are to launch a military assault against Al-Qaeda fighters and insurgents in Diyala province from August 1, army and police officers said yesterday.

"The operation is aimed at cleansing the region of insurgents, Al-Qaeda and militias who are still there," a senior Iraqi military officer told AFP on condition of anonymity.

He said some 30,000 soldiers and policemen from across Iraq would take part in the crackdown in the central province starting August 1.

"It will be an operation led bythe Iraqi army. The US army will probably only watch... If they need help, we'll help them. If not, we will not do anything," a US military officer said.

Iraq's interior ministry spokesman Major General Abdul Karim Khalaf announced on July 13 that the Iraqi military would launch an assault in Diyala but did not specify the date.

He said troops expected tough fighting during the assault.

Diyala and its capital Baquba are Iraq's most dangerous regions with insurgents regularly carrying Senior Iraqi police officials in out attacks, including by female
