The People's Republic of Bangladesh has received a loan under Sustainable Power Sector Development Project from the Asian Development Bank (ADB) and it is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract No. PGCB/SPSDP/TL/4/Lot-1 & Lot-2 for Design, Supply, Erection, Testing and Commissioning of 132kV Underground Transmission Lines on Turnkey Basis [Lot-1 & Lot-2].

2. The Power Grid Company of Bangladesh Ltd. ("the Employer") invites sealed bids from eligible bidders for Design, Supply, Erection, Testing and Commissioning of 132kV Underground Transmission Lines on Turnkey Basis [Lot-1 & Lot-2] as defined in the bidding document (hereinafter referred to as "the Works"). The Works are divided into following two lots:

Design, supply, delivery, installation, testing & commissioning on turnkey basis of 132kV double circuit Old Airport - Dhaka University underground XLPE cable transmission line (approx. 7km) which includes 132kV double circuit underground transmission line from proposed Old Airport 230/132kV Substation to Dhaka University 132/33kV Substation.

Lot-2:
Design, supply, delivery, installation, testing & commissioning on turnkey basis of 132kV double circuit Old Airport-Dhaka Cantonment underground XLPE cable transmission line (approx. 5km) which includes 132kV double circuit underground transmission line from proposed Old Airport 230/132kV Substation to proposed Dhaka Cantonment 132/33kV Substation.

A bidder may participate in the bidding for any or both the above lots by submitting appropriate amount of bid security. Bids will be evaluated lot-wise.

3. International Competitive Bidding will be conducted in accordance with ADB's Single-Stage, Two-Envelope bidding procedure and is open to all bidders from eligible source countries.

4. Bidders shall meet, for each lot separately, the following minimum requirements along with other requirements as mentioned in the bidding documents:

Applicable for Lot-1 & Lot-2 separately

(a) Bidders (partner in charge in case of Joint Venture) must have successfully completed on turnkey basis, at least three (3) comparable contracts (i.e. Design, supply, installation and commissioning of minimum 2km double/single circuit underground transmission lines of 110 kV or higher voltage in each contract) within the last ten (10) years as on the date of opening of technical proposals of which at least one installation shall be in successful operation for minimum of three years.

Bidders must also have project management experience (experience of partner in charge in case of Joint Venture) to demonstrate their management capability in at least one turnkey project (contract amount should not be less than US\$ 3.0 million) outside their own country or in the case of a Bangladeshi Bidder, in Bangladesh or elsewhere within the last ten (10) years as on the date of opening of technical proposals.
