AL candidates rule city polls

Kamran, Hiron win; Khaleque, Liton leading; AL men clinch victory in 8 out of 9 municipalities

Awami League (AL) backed candidates seemed to be striding towards clinching mayoral victory in all four city corporation elections in the early hours of today with Badaruddin Ahmed Kamran already unofficially winning the Sylhet mayoral race, and Shawkat Hossain Hiron winning in Barisal.

Meanwhile, AL candidates already came out as victors in eight out of the nine municipalities where elections were held yesterday, while their archrival BNP backed candidates grabbed only one.

Incumbent Mayor of Sylhet City Corporation Badaruddin Ahmed Kamran won the mayoral election there again according to the final unofficial count, beating his rival BNP candidate AFM Kamal by a large margin. He bagged 1,15,446 votes while his rival got 32,097 votes. Kamran is currently in jail accused in several graft cases.

In Barisal, AL candidate Shawkat Hossain Hiron won the

mayoral race defeating Progressive Democratic Party's Sharfuddin Ahmed Santu, getting 46,795 votes while Santu bagged 46,208 votes. Hiron however earlier accused

Morshed Khan jailed for 13yrs

Assets worth Tk 82 lakh to be confiscated

A special court yesterday sentenced former foreign minister M Morshed Khan to 13 years' rigorous imprisonment (RI) for amassing wealth illegally and concealing information in his wealth statement submitted to the Anti-Corruption Commission (ACC).

Judge M Sirajul Islam of the Special Court-7 on the Jatiya Sangsad Bhaban premises also fined Morshed Tk 10 lakh, in default of which he has to serve jail term for one more year.

The court ordered confiscation of Morshed's ill-gotten wealth worth Tk 82.22 lakh.

The former minister, also a BNP leader, was handed down 10 years' RI for acquiring wealth through dishonest means and three years' RI for hiding information about his wealth. The jail terms will run consecutively, the court said.

Since Morshed is absconding, the sentences will come into effect the day he surrenders or is arrested. His wife Nasrin Khan, who also



is on the run, was accused in the case for aiding and abetting him in the illegal earning. But the High Court quashed corruption proceedings against her.

ACC Assistant Director Talebor Rahman filed the case against Morshed and his wife with Gulshan Police Station on December 10 last year for amassing wealth worth Tk 1.70 crore illegally and concealing information about wealth worth Tk 91.34 lakh.

We roamed the Pabla Khali forest for two days, inspecting every swamp, every tall tree, every creek, every hill. We listened for the calls. But in the end, we knew the white winged wood ducks no longer exist here. Bangladesh has lost another species.

We wandered through the Madhupur forest in search of barking deer. We asked the people around if they had seen one in the wild. In the end we came to the conclusion that this is yet another lost case for the forest.

As The Daily Star team travelled with Dr Reza Khan, a

They rushed to roof, only to be burnt alive

"It seemed the flames spiralled up the staircase and chased down eight members of a family burning them alive as they were climbing up the staircase to the roof," said Abdul Khaleq, who witnessed the tragedy from behind the glass door of his flat on the building.

"Only those who tried to go up to the roof died. The fire did not enter any rooms of the building and therefore 18-year-old Shanto is the lone survivor of the family as he was in a room on the first floor," Khaleq said.

Nine people died early yesterday in a fire at a five-storey building on Aga Sadeq Road in Old Dhaka, eight of a family and the family's house help. Twenty others of the building were also injured.

DEPORTED WORKERS Kuwait to pay arrears thru' embassy

Kuwait will pay the deported Bangladeshi workers their arrears and other benefits through the Bangladesh Embassy in Kuwait, said a foreign ministry press release yesterday.

Following discussions with the Bangladesh Embassy, Kuwait's social affairs and labour ministry and finance ministry decided to collect the addresses of the deported Bangladeshi workers from the companies concerned and hand over their due salaries and other benefits to the Bangladesh Embassy.

Meanwhile, with the latest arrival of 90 workers yesterday, the total number of deported Bangladeshi workers stands at 687 in the last six days.

The Bangladesh Embassy is in touch with Kuwait's labour department all the time, said the press

Mukul was employed by the company Al Abras and was stationed at Mahbullah. He said, "I was sleeping in the barrack when many workers went on strike outside. Suddenly the police entered our barrack and started beating up us."

The military arrested them and forced them to sit on hot sand for one and a half hours before putting them into detention cell.

"In the cell, the police treated us as if we were animals. They beat up with strong rods whenever anyone tried to speak or stand up in the rooms crowded with six to seven hundred workers."

Mukul added he had not a single penny when he returned home.
