'Rebel' Khulna AL leaders to face action

Khulna Awami League will take disciplinary action against one mayoral and 38 councillor candidates who contested the August 4 KCC elections defying decision of the party.

Actions will also be taken against those party men who worked directly or indirectly against Talukder Abdul Khaleque who got green signal from AL-led 14-party alliance to contest in the KCC may oral race, said city AL secretary Mizanur Rahman Mizan.

Actions will be taken at a party meeting soon, he said.

Mayoral candidate advocate Enayet Ali, who contested Khaleque in the KCC polls is a prominent member of the executive committee of Khulna city Awami League.

Supported by a group of dissident party leaders and workers not loyal to Khaleque, Enayet Ali had turned down repeated requests of some local and central leaders to stay out of the mayoral race in favour of Talukder Abdul Khaleque.

Councillor candidates who contested the polls without party nod will not be spared, said Khulna city AL president and mayor-elect Talukder Abdul Khaleque.

Bank of Ceylon manager sued in Sylhet

Authorities of Commercial Bank of Ceylon has filed a case against the manager of the bank's Sylhet branch, Shibli A Chowdhury, who went into hiding along with his family on June 1 after misappropriating a huge amount of money from depositors' accounts.

In his ejahar filed with the Sylhet Kotlwali Police Station, Safayet Hossain, assistant manager of the Bank's Sylhet branch in the city's Dargah Gate, alleged that Manager Shibli A Chowdhury had misappropriated at least Tk 1,65,61,000.

Police sent the case to the deputy director of Anti-Corruption Commission, Sylhet regional office yesterday afternoon.

Following the complaints from depositors about embezzling their money, a team from the bank's head office conducted investigations that revealed that the manager had transferred money to other accounts by putting fake signature of depositors.

Local engineers save Tk 100cr in foreign currency

150MW Ashuganj power unit repaired in one-third of time sought by foreign experts

Foreign currency equivalent to Tk 100 crore has been saved as engineers and technicians of Ashuganj Power Station Company Limited (APSCL) have successfully repaired 150 megawatt Unit 3.

Local engineers and technicians completed the task in 85 days at a cost of Tk 29 lakh only while German firm Alstom, which also did overhauling work of the uled time. They took more than nine months for the purpose, said Md Nurul Alam, director (Technical) of APSCL.

As Unit 3, the 'best one' of all the eight units of APSCL, went out of order due to turbine fault on May 13 this year, the authorities sion of engineer Md Nurul Alam,

urgently contacted German manufacturing company Alstom that supplied equipment of this unit and completed its instillation in 1986, APSCL office sources said.

Authorities of the foreign firm said it will take at least nine months for them to repair unit 3 while the cost would be at least 100 crore taka.

The foreigners earlier failed to complete work within the schedunit in 2003, had said it would take two years in doing overhauling of three to four days," APSCL Unit -- 5 although it could be Managing Director engineer completed by one year, APSCL Abdul Khalequesaid. officials said.

Retrial of Prof Taher murder case demanded

Rajshahi University (RU) Geology and Mining Department teachers, students and officials yesterday demanded retrial of Prof S Taher Ahmed Murder Case after proper reinvestigation.

They put forward the demand at a discussion held at the department at an inaugural function of Professor S Taher Ahmed Micropaleontology Lab, a modern lab. Acting vice chancellor Prof Mamnunul Keramat opened the lab as chief guest. Departmental chairman Prof Kamrul Hassan Majumder chaired the occasion.

Discussants rejected the verdict of the case where Prof Taher's main killer Mahbubul Alam Salehi, also former RU Shibir president remained unpunished.

Prof Taher, a senior teacher of the department was killed on February 1, 2006. Three days later, the body was recovered from an underground pipe of sewer line behind his campus residence.

While opening the lab, the acting VC observed one-minute silence in memory of Prof Taher and placed wreath at his portrait. He paid rich tributes to Prof Taher terming him a brave teacher who 'never compromised' with injustice in his lifetime. He assured the gathering that he would do the needful in fulfilling their demand. Acting registrar Prof Muhammad Shafi and proctor Enamul Haque

were also present. They said Prof Taher always fought for establishing truth and was killed for his refusal to negotiate with the culprits, they said.

Khulna BNP bigwig demands CEC's resignation

Member-secretary of Khulna city BNP convening committee Shaharuzzaman Martuza yesterday demanded resignation of the Chief Election Commissioner and two other Election Commissioners for what he called holding stagemanaged elections to four city corporations and nine pourasavas to make AL mayoral candidates winners.

He also demanded re-election to the four city corporations and nine pourasavas.

The BNP leader admitted that Jamaat-e-Islami, inspite of being a component of four-party alliance, did not play a fair role in Khulna City Corporation (KCC) election in favour of Moniruzzaman Moni. "This was one of the factors which helped Awami League candidate Talukder Khaleque win the mayoral race", he said.

Addressing a press conference at Khulna Press Club, he also alleged rigging in KCC elections.

"This is for the first time in the history of Bangladesh that counterfoils of ballots and unused ballot papers were recovered from outside a polling centre in Khulna although there were so many instances of massive polls rigging in previous elections in the country", Martuza said. "We are really surprised when

the Election Commission claims that 81 percent votes were cast in the August 4 KCC elections while a large number of voters could not cast their votes due to flawed voter list and foul weather", he said. The BNP leader doubted if

upcoming upazilla and parliamentary elections would at all be free and fair under the present Chief Election Commissioner.

Martuza, who is loyal to convicted ex-lawmaker Ali Asgar lobi of BNP and incumbent president of Khulna Chamber of Commerce and Industry, also demanded unconditional release of Begum Khaleda Zia and Tarique Rahman.
