Pak Parliament sets up panel to monitor Kashmir situation

Ignoring India's assertions that Islamabad should not interfere in its affairs, Pakistan's Parliament today decided to set up a panel to monitor human rights situation in Jammu and Kashmir and mobilise world opinion in support of the "right of self-determination" for Kashmiri people.

Ruling Pakistan People's Party leader and Law Minister Farooq Naek moved a motion for setting up a special panel on Kashmir comprising parliamentarians in the National Assembly and it was passed unanimously by the lower house.

Obama close to naming VP pick

Speculation about Barack Obama's vice presidential nominee hit new heights as a report said he had all but settled on a number two and could reveal his choice as early as Wednesday.

The New York Times reported the presumptive Democratic nominee had not yet notified his selection, but was focusing mainly on Virginia Governor Tim Kaine, Indiana Senator Evan Bayh and foreign policy expert Senator Joseph Biden.

Fresh buzz about Obama's intentions came as he sharpened his attacks against Republican rival John McCain, exactly a week before the Democratic nominating con-

vention opens in Denver, Colorado. Running mate anticipation was also building on the Republican side, as the Politico website and Fox News said McCain would name his running mate on August 29, the day after Obama's acceptance speech before 70,000 people in Denver.

War prisoners exchanged

Georgia's Interior Ministry yesterday dismissed a pullback of Russian military vehicles from the city of Gori as a "show" and insisted no pullback was under way.

"It is a show aimed at creating the illusion of a withdrawal," ministry spokesman Shota Utiashvili told AFP. "No tank, no Russian soldier has

left Georgia," he added. Journalists earlier saw a column of Russian armoured vehicles pull away from Gori, following orders to move to the rebel city of Tskhinvali and from there to the southern Russian city of Vladikavkaz.

Both sides have accused the other of violating a peace plan

brokered by France to end the conflict between Russia and its southern neighbour Georgia.

Earlier Russia and Georgia exchanged prisoners captured during their brief war, a move that may reduce tensions and, Georgia hopes, hasten the promised withdrawal of Russian troops.


Georgian Security Council head Alexander Lomaia said the swap removes any pretext for Russians to hold positions in Igoeti. The village is the closest that Russian forces have advanced to the Georgian capital, Tbilisi, about 30 miles away.

Yet as Nato foreign ministers prepared to hold an emergency meeting in Brussels over a unified response to Russia's invasion of its

tiny neighbour, there still was no sign of the Russian troop pullout from Georgia that was supposed to have begun Monday.

A Russian defence official indicated Tuesday that a complete withdrawal from Georgia proper was not imminent.

"Rear units, as well as secondand third-echelon units are being pulled back first. The vanguard units will be pulled back at the final stage," Col Igor Konashenkov, a spokesman for Russia's land forces, was quoted as saying by the Interfax news agency. Tuesday's prisoner exchange, witnessed by Lomaia and Russian Maj. Gen. Vyachesłav Borisov, included 15 Georgians and five Russians, Lomaia said.

23 killed in Pakistan hospital bomb blast

Five soldiers, 13 militants die in clashes

the parliamentary election in time. The AL will also seek to persuade the caretaker government into lifting the state of emergency before the parliamentary election and release party chief Sheikh Hasina permanently, AL sources said.

Party policymakers said if the talks are held, they will categorically tell the government that the AL would not take part in any polls if emergency is not lifted. The party is already mobilising international community to put pressure on the caretaker government to lift the state of emergency. They want to discuss issues like

a few provisions of the People's Representation Order including scrapping of front organisations and foreign chapters of parties, the option for "no" vote, role of the army during the polls, political parties' registration and holding of party council, national poll schedule and environment for the election, competence of the EC, candidates' poll expenses, mismanagement of voter's slip in the August 4 polls, administrative reforms and formation of constitutional coun-

The AL and the government held unofficial talks immediately after the release of AL President Sheikh Hasina on June 11 and the first round official dialogue on July 3 where the AL raised these issues and demanded withdrawal of the emergency without further delay.

The government wanted to hold another round of talks with the AL leaders but there has been no development in the government

the talks, senior AL leaders would consult with Hasina about the crucial issues and hold a meeting of the party presidium to finalise

"We want to hold the dialogue with the government and the **Election Commission after August** 21," said AL Presidium member Suranjit Sengupta.

"Lifting of emergency, holding of parliamentary polls first and permanent release of Sheikh Hasina will be our main issues for discussion," he told The Daily Star.

Hasina's Political Secretary and party Organising Secretary Saber Hossain Chowdhury said, "At the talks we will point out the inadequacy in the Election Commission's competence level and ask it to concentrate on the issue from now because it could be an important factor for poll
