#### upazila polls first: Hasina

STAFF CORRESPONDENT

Awami League (AL) President Sheikh Hasina yesterday said her party will never accept elections to upazila parishad ahead of the general election.

She however vowed to hold local-government polls in six months if her party were voted to power in the next elections.

She was speaking at a viewexchange meeting with the AL's US chapter leaders in New York City, according to US-based news agency News World.

The AL chief again called on the interim government to hand over power to an elected government through holding the national elections first, saying the present crises will not otherwise go away.

Laying out the plan of a future Awami League government, she said they will raise literacy to 80-90 percent, provide free education for all up to honours level, ensure food

The Election Commission (EC) might sit with BNP in a day or two, and announce dates for upazila and parliamentary polls early next

In a major breakthrough, BNP yesterday asked the EC to arrange a meeting to discuss the electoral issues including the most contentious one that is registration of the political parties.

The party that has only recently agreed to join dialogue with the EC communicated its formal acceptance of invitation in a letter to the chief election commissioner (CEC) at around 1:30pm.

#### Patients turn up for 'torture' at DMCH

#### Lack of staff makes medicare all the more awful

Facilities available at the 1,700-bed Dhaka Medical College and Hospital (DMCH) are inadequate to meet the demand of patients who throng there every day for treatment.

Experts say the hospital, running with one-third of the manpower it needs, is also making ill use of its available -- though inadequate -- infrastructure and logis-

On an average some 2,500 patients receive indoor service from the hospital round the clock.

According to hospital sources, the total manpower of DMCH stands at 2,027 at present including 246 doctors in 48 units under 24 departments and 653 nurses. Meanwhile, 172 posts of doctors, nurses and other class three and four employees remain vacant.

Experts say, the size of the hospital demands at least triple the manpower it possesses at present. There has been no recruitment at

the hospital since 2004 and the existing number of staff is on the decline because of retirements. There are, however, some pro-

fessors, associate and assistant professors and honorary physicians, other than the staff, who are attached with the medical college and are considered visiting experts at the hospital. Dr Mohammad Faizullah, assis-

tant director of the hospital, says at least 650 additional manpower, including doctors, are needed to deal with the existing patient load which is already beyond the capacity of the hospital.

Experts say that a hospital providing 24-hour service must have at least three shifts, as it is not possible for any person to work round the clock. At present the DMCH staff capability means that only the needs of a single shift are met, on paper. In reality these employees are scattered to work round the clock at the hospital.

Armed criminals vesterday gunned down an industrialist in broad daylight at Kakrail in the capital.

The dead was identified as Mohammad Abdus Salam alias Babu, 40, a director of Yolk Garments Ltd and also a partner of Yolk Group.

The victim's family members said Babu along with his son Sanjidul Alam left his house Saj Villa at Bijoy Nagar by a car at about 7:00am and dropped Sanjidul at Oxford International School in the

city's Dhanmondi. Babu came under attack when he reached near his office on Purana Paltan Lane at about 7:30am, sources said.
