#### HC judge feels embarrassed to hear Hasina's . stay petition

A vacation bench of the High Court (HC) yesterday felt embarrassed to hear a petition filed by Awami League chief Sheikh Hasina, now abroad on parole, seeking stay on the proceedings of the MiG-29 war plane purchase corruption case.

The HC bench comprised of justices Mirza Hussain Haider and Mamnoon Rahman was set for hearing the petition but one of the judges felt embarrassed to hear it.

Hasina's counsels then requested the chief justice to constitute another bench for hearing.

At their request Chief Justice MM Ruhul Amin sent the petition to the bench of justices AFM Abdur Rahman and SM Emdadul Hoque for hearing the petition today.

Polls dates to be declared Monday

All signs now suggest that the much debated upazila elections will not poll after all, as the government and the Election Commission (EC) seem to be finally moving towards conceding to political parties' almost unanimous demand for the national ballot first.

With the latent new turn in the electoral course developing, the EC will announce on Monday specific dates for the parliamentary, upazila parishad, and Dhaka City Corporation (DCC) polls.

A journey towards downtown Motijheel during peak hours from anywhere seems a nightmare as traffic gridlock has become an irreversible predicament.

Urban experts apprehend traffic

and man-hour for the gridlock, the city commuters have to count extra money as drivers of taxicabs, CNGrun three-wheelers and rickshawpullers charge almost double to go there, if anyone agrees to go.

Illegal parking of hundreds of vehicles on the roads, movement of slow-moving rickshaws, and occupying of walkways by street hawkers and shop owners are the reasons behind traffic congestion.


Many furniture shops in nearby Fakirer Pool even display their products on the walkways.

As there is no foot-over bridge in the business hub, a large number of people cross the roads indiscriminately, further slowing down the traffic. Traffic policemen say a footover bridge is a must near Shapla Chattar and they have repeatedly informed the matter to higher authorities in vain.

The loss of man-hour and wastage of huge fuel have forced many big business houses to shift offices from Motijheel, businesses say.

"As people and vehicles have increased to a great number but roads remain the same, more than 30 percent of the roads is occupied by parked cars," urban expert and honorary chairman of Centre for Urban Studies Prof Nazrul Islam told The Daily Star.

He said it will take 15-20 years to construct parking facilities, but in the meantime traffic congestion will turn so fearsome that people

# 16 killed in attack on US Khaleda asks embassy in Yemen

AFP, Sanaa

Islamist militants attacked the US embassy in the Yemeni capital Sanaa with a car bomb and rockets yesterday, leaving 16 people dead, in the second strike on the highsecurity compound in six months.

The toll included six Yemeni soldiers, six attackers and four civilians, including an Indian, the interior ministry said.

Meanwhile, the White House on Wednesday denounced an Islamist militant attack on the US embassy

in Yemen's capital Sanaa and fireball. offered condolences to the relatives of Yemenis killed in the strike.

"The United States condemns this attack," said spokesman Gordon Johndroe. "This attack is a reminder of the continuing threat both at home and abroad."
