Graft cases against 11 ex-MPs dropped

ACC cites lack of enough evidence

EMRAN HOSSAIN

(ACC) has decided to exempt 250 graft-accused including 11 former ministers and lawmakers in 121 enough evidence.

The former ministers and lawmakers are from the Awami League, BNP and Jamaat and were accused in 16 cases mainly for

funds and materials meant for The Anti-Corruption Commission relief, cheating, and abuse of

"We have decided to submit final reports in the cases due to lack cases from charges due to lack of of proper evidence," ACC Director General (Admin) Col Hanif Iqbal told The Daily Star last night.

Sources in ACC say the joint forces initiated most of the investigations, but had difficulties collect-

misappropriating government ing evidence strong enough to prove the charges.

Meanwhile, ACC yesterday approved submission of seven proposed charge sheets against 24 people including former state minister for communications Salahuddin Ahmed and exlawmaker Reza Ahmed Bachchu Mollah on charges of power abuse

Leaders of Jamaat-e-Islami said they too have heard about the "blacklists", but did not yet receive

reports say Jatiya Party (JP) has been asked to go to the polls without its Chairman HM Ershad.

But the former military strongman's party, which is considered crucial to tipping the balance in traditionally bipolar electoral contests, has denied getting any list or instructions from the govern-

Nothing on record Barapukuria case stayed

Khaleda, ex-ministers appear in lower court

The High Court (HC) yesterday stayed for three months the proceedings against former prime minister and BNP Chairperson Khaleda Zia in Barapukuria coal mine corruption case filed by the Anti-corruption Commission (ACC).

Meantime, Khaleda appeared before a Dhaka court on the day in connection with this case.

After hearing a petition filed by the former premier, an HC bench comprising Justice Syed Muhammad Dastagir Husain and Justice Farid Ahmed issued a rule upon the government and o the ACC to show cause within two weeks why the proceedings against her in this case should not be

IGP notice portrays police as weak force

The home ministry's rare show cause notice on the inspector general of police (IGP) has enraged the police department leaving it with a feeling that the administration indeed treated the police as a weak force.

IGP Nur Mohammad, who was September 22. served with the show cause notice on October 13, sent reply to the home ministry yesterday.

Meanwhile, top police officials said the show cause notice should have been issued on those who

have been obstructing the promulgation of the Police Ordinance-2007, not the IGP who is frustrated over the non-promulgation of the

The ministry asked the IGP to explain his comments on nonpromulgation of the proposed police ordinance to the media on

The notice also quoted a Jai Jai Din report headlined "Reforms are not carried out as it might go against someone's interest."

Govt advises people to avoid brands in question until matter settled

The government yesterday advised people to refrain temporarily from consuming the brands of powdered milk which the chemistry department of Dhaka University found tainted with melamine.

A meeting of an inter-agency taskforce, formed on October 6, at the commerce ministry yesterday decided to test a few samples of the powdered milks at the BCSIR and the Atomic Energy Commission

labs. The commerce ministry would receive the results through the BSTI, said a government hand-
