Butt has also indicated that he would be introducing new faces as part of his team in next couple of

The West Indies have thrown Pakistan a lifeline, offering to play two Tests against the cricket starved team at a neutral venue next month, Pakistan's top cricket official said Thursday.

Pakistan have not played a single Test this year after Australia postponed their full tour in March over security fears in the wake of deadly suicide bombings and other unrest blamed on Islamic militants.

Pakistan Cricket Board (PCB) chairman Ejaz Butt said the two Tests to be played in Abu Dhabi would be in addition to the three one-day internationals which the two countries have already agreed from November 10-14.

"We have received a proposal from the West Indies Cricket Board about two Tests this November," a year. PCB official told Cricinfo. "Many things have to be considered, such hit by security fears, with other about the security situation.

"The West Indies have offered to play two Tests and we hope the proposal materialises and we find some sponsor for the Test matches," Butt, who took over as chairman of PCB earlier this month, told AFP. "We have to pay the West Indies Cricket Board (for the Tests) according to ICC regulations. Time is short, but I am hopeful something positive will come out.

"It will give our players an ideal opportunity to play some international cricket after a long layoff," said Butt.

Pakistan's last Test was against India in December last year, and if the West Indies' offer falls through, Pakistan's next Test outing will also be against India in January next

Umpires will be allowed to make use of TV replays for all contentious decisions during the Stanford Super Series, which concludes with the 20-million-dollar Stanford 20/20 for 20 between England and Stanford Superstars on November 1 -- the biggest prize on offer currently in the game. The Stanford 20/20 also

announced the panel of umpires for the tournament; it includes Simon Taufel, who has won the International Cricket Council (ICC) umpiring award five years in a row Rudi Koertzen, Asad Rauf and Steve Davis. Jeff Crowe, the match referee, will decide the on-field appointments prior to each of the

six games in the series.

The ICC has been conducting trials involving the use of TV replays, but it remains at an experimental stage and has divided opinion among officials and players alike. Such is the huge amount of money at stake in the forthcoming Stanford 20/20 for 20, however, that the organisers are keen to avoid any on-field disputes for

controversial decisions and, pre-

Former Kenya captain Maurice Odumbe has spoken of his desire to return to international cricket when his five-year ban for associating with a known bookmaker ends next year.

"He has not been found guilty of 'match-fixing' but, as I have indicated, his conduct was outrageously reprehensible," Ebrahim concluded.
