The government did not take any measure as of yesterday to stop sales and display of eight brands of 'melamine-contaminated' powdered milk at shops as per a High Court (HC) order and most of these brands are still on the market.

An industries ministry official said the government did not take any step as it had not received any certified copy of the HC order that banned sales and display of those products until receipt of test results from laboratories at home and

Meanwhile, one of the companies that sells three of the popular powdered milk brands suspected to be contaminated with toxic melamine said it is preparing to fight a legal battle if it takes longer to get the test results.

## Govt yet to stop sales of banned milk brands 2 Brac officials kidnapped in Afghanistan

Two Bangladeshi senior Brac officials working in Afghanistan were abducted in the Ghazni province Thursday afternoon.

The identities of the hostages could not be known. Sources, however, said the kidnappers demanded \$100,000 ransom for

their release. While talking to The Daily Star last night, head of Brac overseas programme Aminul Alam said a Brac team from the Afghan capital Kabul was sent to Ghazni after the incident. "We are waiting for details," he added.

Brac official Abdul Alim was shot dead in Afghanistan on September 13, 2007.

# Ban on political activities may be relaxed early Nov

No clear signal on allowing Hasina, Khaleda to contest polls

Despite repeated calls from BNP and Awami League (AL), the government has yet to clear stance on polls participation of Khaleda Zia and Sheikh Hasina, and pledge to lift the state of emergency before the December 18 election.

At the latest round of talks with the parties, the caretaker administration led by Chief Adviser Fakhruddin Ahmed said that early next month it would relax the Emergency Power Rules (EPR) clauses that ban political activities. The move is to allow political

parties to start preparing for the upcoming polls at full throttle, said sources in both the parties that attended the second round talks with the government Thursday.

About the prospect of AL

Chairperson Khaleda Zia being allowed to compete in the election, the government cited legal complexities surrounding the issue, and said it would do its best.

It however said it accepts the two ladies continuing to lead their parties that alternately ruled the country since restoration of democracy in 1990, added the

Following the dialogue, AL and BNP got even louder in their calls for the government to make sure Hasina and Khaleda could stand in the polls.

"We told the government that our party won't take part in the election without Hasina. She has to be allowed to run in the polls as a free person. The government in reply said they would take necessary steps to meet our demands," AL presidium member Abdur President Sheikh Hasina and BNP Razzak told The Daily Star yester-

BNP Joint Secretary General Selima Rahman, who attended the talks with the government, said, "If we decide to go to the polls, we will do so under the leadership of Khaleda Zia."

BNP leaders claimed they did not raise the issue of Khaleda's participation in the election as, they believe, she has no legal bar to taking part in the polls.

On the other hand, AL leaders told the government that Hasina must not be barred from the election since she has no conviction by any court yet.

# Polls under emergency might lead to puppet govt

Says Brig Gen (retd) Hannan Shah

#### Untested Chinese milk Cops find past criminal records of the killer

Mohammad Amin, 32, who killed and beheaded lawyer Nasrin Akhter Tuli Thursday at Segunbagicha, was sent to prison twice before for raping a child in Segunbagicha and stealing in Saudi Arabia.

He had been torturing his wife Yasmin and Tuli protested the abuse which made him angry. He had also made advances to Tuli.

Locals and police sources said Amin had violated a seven-yearold and he was sent to prison for this. After his release in 2002, he went to Saudi Arabia where he was sentenced to four years' imprisonment for stealing.


