Jail Killing Day today

The Jail Killing Day commemorating the assassinations of four national leaders will be observed across the country today.

The four Liberation War heroes -- Syed Nazrul Islam, acting president of Bangladesh government in exile in 1971, Tajuddin Ahmed, prime minister of the same government, M Mansur Ali, finance minister, and AHM Qamaruzzaman, minister for home affairs, relief and rehabilitation -- were gunned down inside the Dhaka Central Jail on November 3, 1975.

The four leaders were assassinated 79 days after Bangabandhu Sheikh Mujibur Rahman along with most of his family members was killed on August 15, 1975.

High-powered govt body to watch impact

Move to curb graft in cop promotion

Police HQs now to deal with upgrading of lower-tier policemen

Amid discontent between constable- and inspector-rank cops over their promotions, the police department has decided to deal with their advancement centrally through the police headquarters, not by divisional, metropolitan and district headquarters of police.

A recent meeting of the Policy Group of the department made the decision to check irregularities and corruption regarding promotion of the lower-rank police. The meeting of 46 police high officials also decided in principle to directly recruit no more traffic sergeants to avoid complications regarding their promotions.

Sources claim the move was taken as large-scale corruption was detected in connection with the constables, assistant sub-

promotions of police personnel between the ranks of constable and inspector.

Over 98.75 percent of the total police workforce belongs to ranks between these two ranks.

Currently, traffic sergeants have no scope for promotion. About 800 traffic sergeants are working in the same post for 10 years and many have been in the same post for about 20 years.

Sources also said criminals often use vehicles for committing criminal acts but the traffic policemen do not have the expertise to tackle those criminals. Therefore, the headquarters decided to deploy policemen who are capable of controlling traffic movement as well as deal with those situations.

Promotions of constables, head

inspectors (ASI), sub-inspectors (SI) and inspectors are to be decided through tests. The candidates would be tested through coded answer sheets so that the identity of the candidate is kept concealed. The answer scripts would be sent to the headquarters for consideration. This would reduce the chances of corruption, sources said.

Traffic sergeants would be made SI (traffic) and policemen selected for traffic controlling would be identified as SI (traffic).

Talking to The Daily Star about the new decisions on promotions, Additional Inspector General of Police (Addl IGP-Admin) NBK Tripura said, "The decision has been made as a number of incidents of breach of trust took place earlier."

Freed Brac staff to fly in tomorrow

The release of the two abducted Brac officials in Afghanistan has brought immense relief and joy to their families, who now eagerly wait to be reunited with them.

The two senior officials of Brac, Akhter Ali and Shahjahan Ali, were freed unhurt by their captors on Saturday evening, 10 days into their abduction from the Afghan province of Ghazni.

They are expected to return to Bangladesh tomorrow, or the day

Brac officials said that the two men are in good health and they were not hurt during their captivity. Both were released in front of their office in Ghazni on Saturday evening. The two men were flown to Kabul at around 11:00am yesterday after spending the night in Ghazni.

The motive behind their abduction or the identity of their captors is still not clear. Brac officials said that the men were not being pressed for information at present as they are still under mental stress.

Hundreds of commuters could not reach their workstations, while many others were seen stranded at different points on the busy route. Besides, many walked in a desperate bid to attend their offices in

The angry commuters went on the rampage and vandalised over 12 buses.

Earlier at about 8:00am at Farmgate, staffs of a Mirpur-bound bus from Gulistan had an altercation with passengers, who pressed for reduced bus fares citing the recent cut in fuel prices.

At one stage, the angry passengers manhandled the employees of Safety Paribahan that led to a wildcat strike on the route.

7 more die in Bogra

Seven more people died in different parts of the district after drinking toxic alcohol raising the death toll to 21 in Bogra and Joypurhat till yesterday evening.

Police said those who died yesterday and Saturday night were Chittoranjan Saha, 35, Abdul Bari Ronju, 42, and AKM Mozammel Haque, 55, of Dhunat upazila, Abdur Rashid, 45, of Sariakandi upazila, Afzal, 42, of Sadar upazila, Rafiqul Islam, 42, of Sherpur upazila and Helal Uddin, 40, of Shahjahanpur upazila.

With the new deaths, a total of 17 people perished only in Bogra

while four others in Kalai upazila of Joypurhat district.

Meanwhile, police sealed off four homeo shops and arrested nine people, including one woman, from different areas of Sadar, Adamdighi and Shahjahanpur upazilas on charges of selling and possessing alcohol.

Of them, housewife Papia and her husband Moksed Ali along with two others were arrested from Shahjahanpur upazila.

The sealed shops are Parul Homeo Hall, a laboratory owned by BNP leader Noor Mohammad's brother Noor Islam, Globe Laboratory, Wilson Homeo Hall

Suicide car bomb kills 8 Pak troops

A suicide car bomber killed at least eight Pakistani paramilitary troops vesterday in a region near the Afghan border that has been a target in a surge of suspected US missile strikes.

The bomber rammed his vehicle into a checkpoint near the main gate of the Zalai Fort, exploding it as Frontier Corps troops gathered nearby, said Maj Gen Athar Abbas, the Pakistan army's top spokesman. Four people were wounded, he said.

The fort is 20km outside Wana,

the main town in South Waziristan, a tribal region considered a hub for al-Qaeda and Taliban fighters involved in attacks on US and Nato

troops in Afghanistan. South Waziristan was the site of one of two alleged US missiles attacks Friday that killed 29 people, including several suspected foreign militants, intelligence officials said.

It was not immediately clear if Sunday's suicide attack was linked to the missile strikes. However, the missile strikes have strained Pakistan's alliance with the US in its war on terror and spurred militant calls for revenge.

The Pakistani troops were washing their vehicles Sunday when the suicide attacker came, two intelligence officials said. They described the explosion as "large" and said it destroyed the checkpoint and damaged the front wall of the fort.

The intelligence officials spoke on condition of anonymity because they were not authorised to speak to media. It was not possible to immediately verify the details. South Waziristan is a dangerous, remote area where travel by foreigners and many journalists is restricted.




