NATIONAL Magura AL feud rolls into court Satkhira AL

Rivals seek court order to stop functioning of 'illegal' district committee, sue ex-MP Akbar and dist unit president

Intra-party feud in Magura Awami League intensified yesterday as rival party men in Sreepur upazila unit sued seven leaders of the district committee including its president Altaf Hossain and former secretary Dr. MS Akbar.

Sreepur upazila AL president Akbar Hossain Mian and its executive committee member Molla Nabuot Ali jointly filed the case with Assistant Judge's Court (Magura Sadar) terming the existing seven-member district committee illegal and prayed for an injunction on functioning of the 'so-called' committee.

In the case the plaintiffs alleged that the committee members resorted to 'swindling' and 'cheating' in forming it and prayed for declaring it 'illegal' as it defied party constitution.

The then Awami League general secretary Abdul Jalil at a council lawmaker and district unit general meeting on April 4, 2005 announced an eight-member district committee with a directive to form a full-fledged committee within 90 days, party sources said.

However, they failed to form a full-fledged committee even after 31 months of the council. In the meantime, joint-secretary no.2 of the committee, Sreepur municipality chairman Abdul Gafur, quit the party alleging lack of discipline.

Internal feud in Sreepur AL increased recently over former lawmaker Dr. Akbabr's nomination from Magura-1 constituency (comprising Magura Sadar and Sreepur upazila) in the next general elec-During submission in favour of tion. having alleged link with Jamaat and BNP men. Leaders of the faction also vowed to resist him in the constituency.

The other faction led by Sreepur AL general secretary Nurul Hossain Molla at a press conference at Magura Press Club recently extended their support to former lawmaker Dr. Akbar. The press conference organised under the banner of Sreepur upazila AL was also attended by district AL president Md. Altaf Hossain.

After Nurul Hossain's press conference, aggrieved rival party at an extended meeting at Sreepur Girls School auditorium on October 31 removed Nurul Hossain

Molla from the post of general secretary and made joint-secretary no.1 Rostam Ali Mondol acting secretary.

The internal conflict became public when rival party men at a press conference on October 17 at Sreepur upazila public library auditorium declared former lawmaker Dr. Akbar 'unwanted' in the upazila. Later, they also held a meeting at Dariapur bazaar on October 21 to oppose Akbar's nomination.

They held several meetings in different areas of the constituency declaring Dr. Akbar 'unwanted' and vowed to resist him in the constitu-

When asked, Akbar Hossain Mian said, "We have filed the case accusing leaders of the so-called district committee as we consider it illegal. We have also adopted a resolution to place it before our central leaders so that they do not nominate Dr Akbar again".

Former lawmaker Dr. Akbar could not be reached as he is reportedly in Dhaka and his cell phone was found switched



Failing to narrow down rivalry between party leaders, AL Presidium member and veteran

leader Abdul Mannan contested from the constituency in 1991 election but he lost to BNP's Khondokar Abu Taher with a margin of 14,909 votes.

After the 1991 election, Jatiya Samajtantrik Dal (JSD) leader Freedom Fighter Khondokar Abdul Baten joined AL along with his followers in 1992. Some local (Nagarpur) AL leaders and activists were disappointed over his joining and started opposing Baten. Baten ran in 1996 election as an AL candidate but was defeated by BNP's Gautam Chakroborty. The vote difference was however narrowed down to 1,950.

Baten got the party ticket again in 2001, but was defeated by 4-party alliance candidate Gautam Chakroborty with a margin of 1,878 votes.

Many AL party leaders blamed the then Nagarpur upazila party president Golam Mohammad Khan Tareque for the defeat Denied of party ticket, he contested the election as an independent candidate and got only dis 462

Several AL leaders declared their candidature from the constituency in the planned election of January 22, 2007 which was postponed.

Party sources said Khondokar Baten is known as an honest politician to the party men as well as people. Now that Delduar upazila has been added to Tangail-6, his prospects have become brighter, they said. AL lost in 1996 and 2001 elections due to inter-party feud.

When contacted, Khondokar Baten said he was defeated by BNP candidate in last two elections with little margins due to hostility by some party men.

They urged central AL leaders to nominate competent and honest AL men for all the four constituencies in the district.

They also warned of tougher programmes if 'weak candidates' from its allies are nominated instead of 'competent and honest' local AL leaders.

Satkhira district AL organising Secretary Firoz Ahmed read out a written statement at the press conference.

District AL president Sheikh Mujibur Rahman, Workers Party (WP) leader Mustafa Lutfullah and LDP leader Syed Didar Bakht are seeking nomination from Satkhira-1 to contest the next election while JP leaders Abdul Jabbar and Golam Reza are aspirants for nomination from Satkhira-2 and Satkhira-4 constituencies, he said.

Trial of Awami League leader SAMS Kibria murder case will resume at Sylhet Divisional Speedy Trial Tribunal today.


The trial remained suspended for 9 months as there was no tribunal judge. High Court order staying trial of

Talking to this correspondent yesterday, IO Rafiqul Islam said he has collected 'some important information' about involvement of some more people in the sensational killings. There is need of further

The decision for further investigations was taken after Huji link in the killings was found, he said.

Earlier, CID Senior ASP Munshi Atique filed charge sheet in the case on March 20 2005 against 10 people. Chief of Zia Gobeshona Parishad and Vice President of Habiganj district BNP Abdul Quaiyum was made the principal accused. The other accused are, Zainal Abedin, Jamir Ali, Momin Ali, Tajul Islam, Shahed Ali,

Among them eight including Abdul Quaiyum were in jail while two others are yet to be arrested. Quaiyum, granted bail weeks ago, claimed he was implicated in the Hnnan, leader of Islamist militant case by certain quarters.

Pabna centres to buy cow milk after test

Milk collection centres in Santhia upazila will buy cow milk after laboratory test conducted by expert technicians.

The decision was taken at a meeting at Santhia UNO office on Monday where officials from local administrative and health department and representatives of private milk collection centres were present, reports our Pabna correspondent.

"In the meeting we ordered the private milk collection centres to recruit expert technician for test of

milk at the collection centres," Santhia Upazila Nirbahi Officer Md Abdur Razzak told this correspondent yesterday over phone.

"We also instructed the private milk collection centres to give information about the culprits who will come to the centre with spurious milk. We will send formal orders to private milk collection centres within one or two days," he said.

"There is no expert technician in most of the milk collection centres for laboratory test of the milk," Dr Md Monsurul Alam, upazila health and family planning officer told this correspondent yesterday. A mobile court on November 3 fined five milk collection centres






