Next govt will have to ratify all reform works

Says AL spokesperson Ashraful

Awami League (AL) yesterday said it would ratify all reform initiatives taken by the caretaker government and officially recognise the laws voted to power in the next parliamentary election.

"Not only Awami League but any political party that forms the next government will have to ratify the present government's activities for its own legality," AL spokesman Syed Ashraful Islam told reporters after holding a meeting with South Asia Director of the British Foreign

and Commonwealth Office Philip Burton and British Ambassador in Dhaka Stephen Evans at the AL leader's Nam flat residence in the

"If the next parliament fails to passed under the current regime, if ratify the caretaker government's activities, the parliament's own legality will be questioned," said Ashraf, also joint general secretary

Poster control ordinance okayed

The council of advisers yesterday approved in principle the Graffiti and Poster Control Ordinance 2008 in order to keep candidates from campaigning by such means.

The new law will also restrict commercial advertisement by graffiti and posters.

"The ordinance has been framed to help enforce the restrictions imposed on graffiti and posters under the electoral code of conduct recently promulgated," it is stated in the objective of the ordinance.

The council of advisers also approved amendments to the amended Representation of People Order (RPO) to reduce time for clearing bank loans and utility bills by candidates, from 15 days to seven days from submission of nomination.

Delwar asks EC to give aspirants time for rescheduling loans till poll day

BNP yesterday demanded fresh poll schedule for the ninth parliamentary election so that its prospective leaders who have been declared loan and utility bill defaulters can take part in it.

Terming the Election Commission's (EC) new poll schedule "juggling of figures", BNP Secretary General Khandaker Delwar Hossain demanded that their aspirant candidates, who are defaulters of bank loans and utility bills, be given time till the day before election day to pay off and take part in the elections.

"You [the EC] will have to announce the poll schedule in such

a way that our candidates who want to contest the elections can get the opportunity," he said during a discussion meeting at the city's Institute of Diploma Engineers.

The meeting was organised to observe the National Revolutionary and Solidarity Day.

Referring to the changes the EC made in the poll schedule, he said it will make no difference as the party's prospective candidates will hardly get any benefit from it.

"You [EC] announced the poll schedule without giving opportunity to our party's prospective candidates to pay off their bank Ioans and utility bills, which we cannot accept."

BNP pulls for bill, Russian nuclear submarine accident kills 20

An accident aboard a Russian nuclear-powered submarine making a test run in the Sea of Japan killed at least 20 people, officials said yesterday.

The nuclear reactor aboard the submarine was operating normally and radiation levels were normal after the accident Saturday, Russian navy spokesman Capt. Igor Dygalo said.

The accident occurred when a fire-extinguishing system went into operation in error aboard the submarine, Dygalo and other officials said. The system is designed to release Freon coolant when activated, according to the ITAR-Tass news agency, which cited an official with Russia's top investigative agency.

It was unclear what activated SEE PAGE 15 COL 6 | the fire-extinguishing system.

The official, Sergei Markin, said 14 civilians and six sailors were killed and 22 others were hospitalized after being evacuated to a destroyer that brought them to the Pacific port of Vladivostok, ITAR-Tass reported.

Earlier, Dygalo said more than 20 people were killed, including sailors and workers from the shipyard that built the submarine, and that 21 were injured and hospitalised. He said there were 208 people aboard, including 81 servicemen. Officials did not reveal the name of the submarine.

It was Russia's worst naval accident since torpedo explosions sank another nuclear-powered submarine, the Kursk, in the Barents Sea in 2000, killing all 118 seamen aboard. In 2003, 11 people died when a submarine that was being taken out of service also sank in the Barents Sea.

Saturday's accident came as the Kremlin flexes its military muscle and seeks to restore Russia's naval reach, part of a drive to show off the nuclear-armed country's clout amid strained ties with the West. A naval squadron is headed to Venezuela for joint exercises this month in a show of force near US

Govt's handling of graft suspects questioned by Justice Habibur

Former chief adviser to a caretaker government Justice Muhammad Habibur Rahman yesterday expressed doubts about the effectiveness of the way the present caretaker government dealt with political leaders suspected of corruption.

"I do not know how effective the non-elected government will be .. they put in jail leaders immediately after cases were filed and then released them ... didn't they think of it before making arrests?" he said at a seminar on rural socio-economic reforms organised by Research Initiatives, Bangladesh (RIB).

Deal signed on Tk 1,000cr Swedish grant

Bangladesh will receive 1.1 billion Swedish kroner, approximately Tk 1,000 crore, under a five-year agreement signed in Dhaka yesterday.

The money will be used in support of Poverty Reduction Strategy and be directed towards the areas of health, primary education, women's rights, democratic governance and urban environment in Bangladesh.

Secretary of the Economic Relations Division M Musharraf Hossain Bhuiyan and Swedish Ambassador Britt Hagstrom signed the agreement on behalf of the respective countries, an official handout said.

The largest share of the cooperation will be channeled to primary health care and primary level education in support of the vision to ensure equitable and qualitative health care and education for all.

"This signals the start of new phase of Swedish cooperation with Bangladesh, a partnership that dates back to 1971," the Swedish envoy said.

Breaking away from the Awami League-led grand alliance, the Bikalpadhara Bangladesh and the Gono Forum yesterday launched a new electoral combine.

The rainbow coalition also takes in Krishak Sramik Janata League, Jatiya Party (Manju), Bangladesh Kalyan Party and Bangladesh Labour Party.

Bikalpadhara President Badruddoza Chowdhury and Gono Forum President Dr Kamal Hossain had worked to patch together the alliance.

"We were in the Awami Leagueled grand alliance before 1/11 in order to save the country from a civil war. Now the situation is different. We'll contest the election from our own platform," Badruddoza told a press conference at the Institute of Engineers, Bangladesh.

He said they will not go back to the Awami League-led alliance. The name of the alliance will be

Badruddoza said the alliance was formed on the basis of a fivepoint principle that include fielding honest, talented and propeople candidates, making Bangladesh free from corruption, poverty and terrorism, and establishing liberal democracy in the

He said they hope to meet people's desire for a new platform and newleadership.

Shamsul's wife Khadiza Anam was also jailed for three years by the same court for assisting her husband in accumulating wealth. Judge Tanzina Ismail of Special

Court-6 set up on the Jatiya Sangsad Bhaban premises also fined Shamsul Tk 88 lakh in default of which he is to suffer one year

Indonesia executes Pakistani airstrike kills 3 Bali bombers

Radicals call for revenge

Three Indonesian Islamists were executed by firing squad early vesterday for the Bali bombings which killed 202 people, sparking calls for revenge from their radical supporters.

Indonesia stepped up security at tourist spots and embassies following the executions of Amrozi, 47, his brother Mukhlas, 48, and ringleader Imam Samudra, 38, which sparked brief clashes between police and hundreds of

The three men were killed with shots to the heart shortly after

midnight near their prison on Nusakambangan island off southern Java, said attorney general's office spokesman Jasman

They refused an offer of blindfolds and cooperated fully with their executioners, he said. "All three convicted men were

very cooperative and didn't resist at all. The families have also been cooperative and sincere," Panjaitan said. A source in the prison told AFP

Four suspected robbers were beaten to death by a mob at Hatbaria village of Santhia upazila in Pabna early yesterday.

The four were identified as Ebadat alias Ebad, 35, regional leader of outlawed PBCP 'Janajuddha' faction and son of Moylal of Vulbaria village, Robiul Islam Robi, 30, son of Mojai, Lal Pramanik, 32, son of Ahmed Pramanik of Bhabanipur village, and Shamim, 28, son of Shahed of Tebaria village in the upazila.

Police said locals rushed to the spot after hearing cries when a gang of 10 to 12 robbers stormed into the house of Abdul Aleem at about 1:00am.

They caught four robbers and beat them up, leaving them dead


