

India detains key accused of Gujarat blasts

Qayamuddin Kapadia, one of the key conspirators of the July 26 serial blasts in the city, has been arrested by the Madhya Pradesh police.

"Qayamuddin Kapadia has been arrested by the MP police. I do not have much details on this matter as of now," joint commissioner of police of city crime branch, Ashish Bhatia told PTI Tuesday.

Qayamuddin, who hails from Vadodra, was declared absconding by the city crime branch investigating the serial blasts cases.

He allegedly planted cycle bombs in the city as well as bombs in different parts of Surat, Bhatia said.

He was also responsible for purchase of cycles on which the bombs were mounted and kept in different parts of the city, he added.

Pak president seeks new US policy

Pakistan's leader said Monday he expects President-elect Barack Obama to re-evaluate the need for US military strikes on al-Qaeda and Taliban targets on Pakistan's side of the Afghan border.

In an interview with The Associated Press, President Asif Ali Zardari warned that the surge in missile attacks since August was hurting Pakistan's own fight against the militants a campaign he said was succeeding nonetheless.

The 52-year-old president is under intense US pressure to take firmer action against militants in the rugged and lawless northwest border zone, a possible hiding place for Osama bin Laden and what many consider to be the

global front line in the fight against al-Qaeda.

In what is seen as a sign of American frustration with Islamabad's perceived inability to deal with the militants, the US military is believed to have carried out at least 18 missile attacks on suspected militant targets close to the border in Pakistan since August.

The missiles are believed to be fired from unmanned planes launched in Afghanistan, where some 32,000 US troops are fighting a resurgent Taliban insurgency.

Zardari said he believed Obama would re-examine that strategy, but acknowledged that the Democrat who struck a sometimes-hawkish tone on dealing with Pakistan during the election

may continue with the attacks.

Obama has openly supported US strikes in the lawless and rugged border region, and has questioned whether Pakistan has done enough to fight militants despite receiving billions of dollars in US aid since 2001.

During the campaign, Obama said if he is elected, he could launch unilateral attacks on high-value terrorist targets in Pakistan as they become exposed and "if Pakistan cannot or will not act" against them.

"I think there is definitely going to be a new look at all the issues that have been on the table of the United States, and this is one of the large issues," said Zardari, who sat in front of two photos of his late wife, Benazir Bhutto, a US-allied moderate Muslim leader who was killed by suspected al-

Qaeda militants in December 2007 as she campaigned in parliamentary elections.

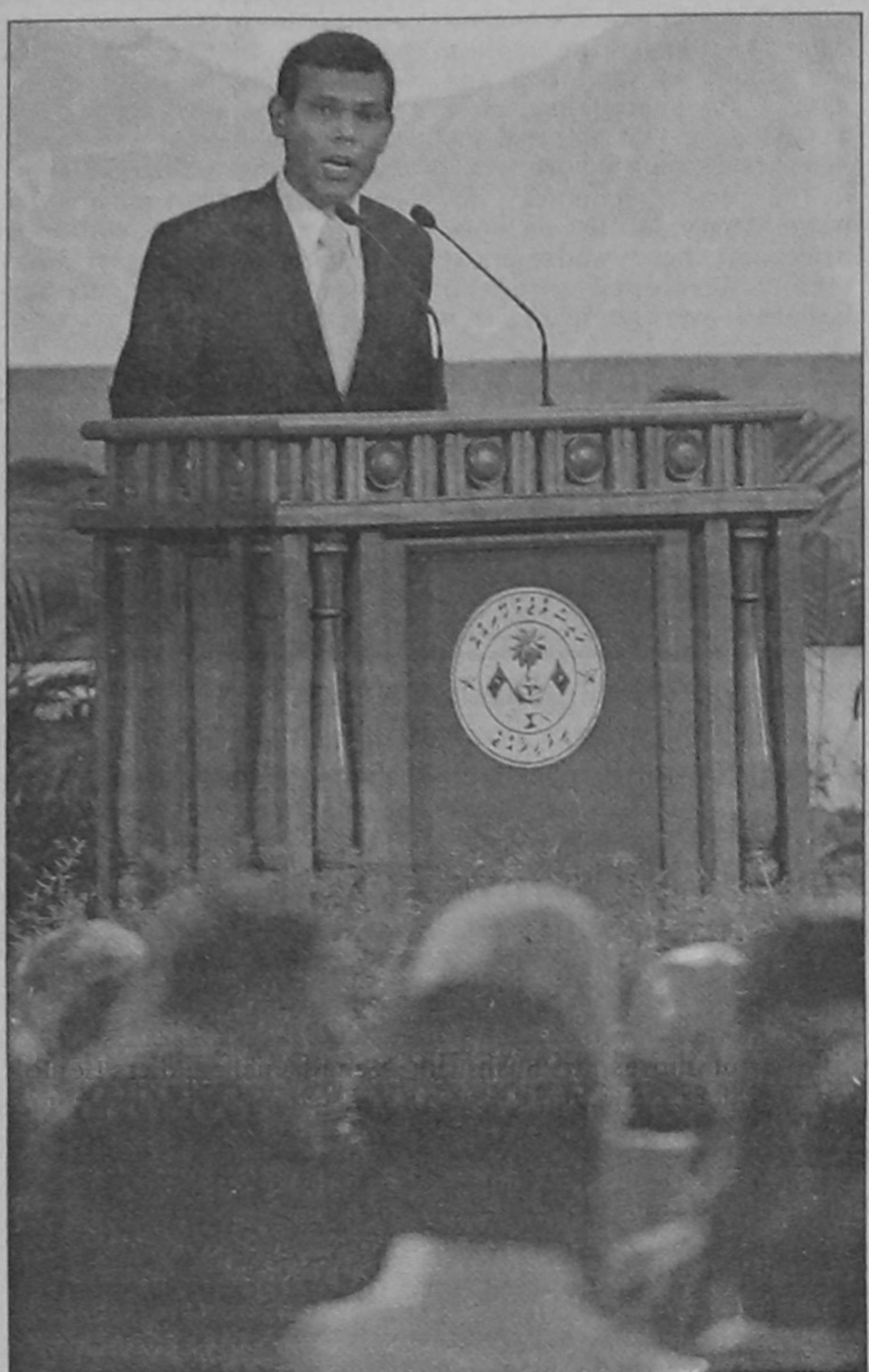
Zardari took over Bhutto's party after her death and was elected president in September, facing a crushing economic crisis and soaring violence by militants also blamed for attacks on US and Nato forces in Afghanistan.

The US attacks have killed some militants, but many of the dead have been civilians, including women and children, stoking anger among locals, Pakistani officials say.

"We feel that the strikes are an intrusion on our sovereignty, which are not appreciated by the people at large, and the first aspect of this war is to win the hearts and mind of the people," Zardari said.

Nasheed sworn in as new Maldives president

Former political activist and prisoner Mohamed Nasheed was today sworn in as the new President of the Indian Ocean archipelago Maldives.

Nasheed, 41, took his oath of office at a ceremony in Male. The former political prisoner was elected in the first ever multi-party elections held in the island nation.

Nasheed beat Maumoon Abdul Gayoom, who had led the nation for 30 years and was Asia's longest-serving leader, in a Presidential run-off on October 28.

Britain lifts ban on civilian nuclear exports to India

Britain has lifted a ban on exporting sensitive nuclear technology to India for civilian projects, it said Monday, after an international accord to relax rules in September.

Since 2002, Britain has refused all export licence applications for so-called "Trigger List" items to India, Foreign Office Minister Bill Rammell said, referring to an agreed list of sensitive technology.

"That policy has now changed and we will now consider on a case-by-case basis licence applications for peaceful use of all items" on the list if they are destined for UN-secured civil nuclear facilities in India, he added.

Myanmar jails 23 NLD activists for 65 yrs each

Twenty-three pro-democracy activists arrested during anti-junta demonstrations in Myanmar last year were sentenced to 65 years each in jail by a special court yesterday, a family member said.

The activists, including several women, were sentenced during a closed-door hearing at the notorious Insein prison on the northern outskirts of the military-ruled country's commercial hub of Yangon.

"Altogether 23 activists were sentenced today at Insein prison.

They were sentenced to 65 years each," the family member told AFP on condition of anonymity.

The group included prominent activist Nilar Thein and her husband, Jimmy, the relative said. According to Amnesty International Nilar Thein had to abandon her baby daughter after going into hiding following the initial protests in August 2007.

A leading member of a group, which led a failed uprising against the junta in Myanmar in 1988, Mie Mie or Thin Thin Aye, was also among them, the relative said.

Indian navy battles pirates in Gulf of Aden

An Indian warship yesterday successfully defended a merchant vessel from being hijacked by pirates in the Gulf of Aden and escorted the ship to safety, a statement from the navy said.

Merchant vessel "Jag Arnav," a 38,000 tonne bulk carrier owned by India's Great Eastern Shipping Co Ltd, had crossed the Suez Canal and was 60 nautical miles east of Aden when it was attacked by pirates, the statement said.

An Indian warship patrolling the area detected an alarm by the crew of the merchant vessel and dispatched "an armed helicopter with marine commandos... to intervene and prevent" a hijacking, it said.

"This timely and successful intervention led to the pirates

aborting their attempt," it said.

The statement did not say how many crew were on board the "Jag Arnav," the nationality of the pirates or the contents of the vessel.

It was the first time the Indian navy has repulsed a pirate attack in the region since New Delhi deployed a warship there last month.

It came after the hijacking in September of the Hong Kong-registered commercial carrier "Stolt Valor," carrying mainly Indian crew, by Somali pirates in the Gulf of Aden, one of the busiest but most pirate-infested shipping lanes in the world.

"The Indian navy has been conducting anti piracy patrols in the Gulf of Aden since October 23 as a sizeable portion of our country's trade flows through the Gulf of Aden," the navy statement.

Lankan troops take rebel town: Military

Government forces in Sri Lanka have wrestled control of a small town from Tamil Tiger rebels in an ongoing military offensive, the defence ministry said yesterday.

Troops fighting to secure a strategic road along the coast to the northern peninsula of Jaffna have faced stiff resistance from the Liberation Tigers of Tamil Eelam (LTTE).

The ministry said that the sol-

diers had taken Palavi, a small town on the road. It described the town as an LTTE "strongpoint."

Security forces have said they are advancing on Kilinochchi, the political capital of the Tamil rebels, though their plans have been delayed due to Tamil defence action and monsoon rains.

Military sources said fighting has raged in the northern regions with both sides suffering casualties, though no details were available.

Jaffna, an area of 2,300 square kilometres (900 square miles) was taken from the Tigers in 1995, but the lack of land access meant that it has had to be supplied via expensive sea and air routes.

Tens of thousands of people have died on both sides of the conflict since 1972, when the LTTE launched its campaign to carve out an independent state in the Sinhalese-majority island of 20 million people.

Indian Speaker accepts resignation of five JD-U MPs

Lok Sabha Speaker, Somnath Chatterjee on Tuesday accepted the resignation of five Janata Dal-United (JD-U) MPs from Bihar who resigned to protest the attacks on north Indians in Mumbai by activists of the Maharashtra Navnirman Sena (MNS).

The five MPs are Prabhunath Singh, Rajiv Ranjan Singh 'Lalan', Kailash Baitha, Meena Singh and George Fernandes. The party has seven Lok Sabha MPs, including one from Uttar Pradesh and one from Lakshadweep.

The MPs had Friday handed over their resignations to P.D.T. Acharya, the Lok Sabha secretary general. Chatterjee, who was discharged from the the Army Research and Referral Hospital Saturday following a bout of bronchopneumonia, was handed over the resignations Monday.
