### Special drive soon to net 2,847 outlaws

AMANUR AMAN, Kushtia

A special drive will be launched soon by the law-enforcement agencies to arrest outlaws of different parties and groups in 10 southwestern districts in accordance with a fresh list before the forthcoming national election.

Police sources said they have taken the decision as the outlaws and criminals, who had fled after 1/11 political changeover, have started to return their localities and try to regroup under the shelter of their 'political godfathers' ahead of the polls.

They said law enforcement and other intelligence agencies have prepared the list of 2,847 criminals, including 73 top figures of different outlawed parties and gangs and 286 cadres, in May.

According to the sources, 845 of the listed cadres are from Khulna while 434 from Jhenidah, 363 from Bagerhat, 360 from Kushtia, 284 from Jessore, 225 from Satkhira, 210 from Chuadanga, 47 each from Meherpur and Narail and 32 from Magura. Most of the criminals are accused in five to 25 criminal cases, including that of murder.

Police said the law enforcement agencies will give more priority to arrest 73 most wanted criminals of different outlawed parties and gangs and 286 cadres.

Decision of the drive has been taken to make the polls free from the influence of underground politics, which is long an important factor in the region, sources said.

Acting Deputy Inspector General of Khulna range Asaduzzaman Miah said the drives would be conducted on the basis of the fresh list of the criminals and outlaws.

Police sources said some leaders of major political parties are directly involved with various criminal groups, including outlawed parties, in the region and they use criminals to establish supremacy in their areas and in vote rigging. Of the top criminals, most of them are from outlawed parties,

including four factions of Purbo Banglar Communist Party

An Indian warship opened fire at a Somali pirate "mother ship", the navy said yesterday, as bandits demanded a ransom for a Saudi super-tanker seized in the most daring sea raid

### US missile strike kills 6 in Pakistan

Joint border operation with Pakistan launched

A suspected US missile strike hit a village deep said, killing six alleged militants and indicating American willingness to pursue insurgents beyond Pakistan's lawless tribal regions. A major Al-Qaeda operative of Arab origin was among the six militants killed in the missile Afghanistan. strike, a senior security official told AFP

Security sources identified the militant as

Abdullah Azam Al-Saudi, a senior member in Osama bin Laden's al-Qaeda network.

"He was a senior commander of al-Qaeda inside Pakistani territory yesterday, officials and was involved in recruiting and training of fighters," the senior official said.

He is the second high-profile al-Qaeda operative killed in recent US missile strikes in Pakistan's rugged tribal region bordering
