## 4-party nominee from Jamaat chargesheeted for corruption

Ex-MP Gazi Nazrul of Satkhira-5 also hid wealth info

The Anti-Corruption Commission (ACC) yesterday submitted charge sheet against former Jamaat-e-Islami lawmaker Gazi Nazrul Islam in a case filed in connection with amassing wealth worth Tk 40.05 lakh illegally and concealing wealth information to the ACC.

The Jamaat leader, who was elected as a BNP-led fourparty alliance candidate from Satkhira-5 constituency in 2001 election, also submitted nomination paper to contest from the newly demarcated Satkhira-4 constituency in the upcoming polls as four-party candidate.

Khulna ACC Deputy Director Monzur Morshed,

also the investigation officer (IO) of the case, submitted the charge sheet before Satkhira Judicial Magistrate's Court mentioning that he amassed wealth worth Tk 40.05 lakh beyond his known sources of income and concealed wealth information.

Judge SM Zakaria of the Judicial Magistrate's Court received the charge sheet yesterday.

On July 4 this year, Monzur filed the case against him with Shyampur Police Station.

Following an ACC notice to submit his wealth information, the former Jamaat law- ACC sources said. maker submitted statement mentioning wealth amounting to Tk 32.74 on September 10 last year, ACC sources said.

immovable property was Tk 17.58 and that of movable property was Tk 15.16, the

After investigation it is found that the former Jamaat lawmaker submitted his statement of property showing value Tk 21.39 less than that of the real value, court sources said.

The former Jamaat lawmaker also concealed property worth Tk 18.65 in his statement, sources said.

After DD Monzur Morshed submitted his investigation report, the ACC approved it and asked him to submit the charge sheet against Nazrul.

The charge sheet was submitted after inquiry into the matter, Monzur Morshed told this correspondent.

Nazrul, whose name was on the second list of corruption suspects published by the ACC, was arrested by the joint forces on March 9 last year and released on bail on February 4 this year.

When contacted, Nazrul said the case filed against him is false and baseless.

SIRAJGANJ-2 AL None but Henry acceptable

### Jamaat campaigns against BNP men in Bogra-4,5

AL's Manna to run independent in Bogra-2

Jamaat-e-Islami is campaigning for party nominee Nazir Ahmed in Bogra-4 (Khaloo-Nandigram) where the 4-party alliance has nominated Engineer Mostafa Ali Mukul in the upcoming polls.

Talking to this correspondent over cell phone yesterday, Bogra Jamaat Ameer Amir Shahab Uddin said, "Our party men have started full swing door to door campaign". He ignored Mostafa Ali Mukal's candidature, claiming that Jamaat has 70,000 voters out of 2,54,740 in the constituency.

In Bogra-2 (Shibgonj), the four-party alliance first nominated former lawmaker AKM Hafizur Rahman but replaced him with former student leader MR Islam Shadhin just before submission of nomination due to intra-party feud.

AL leader Mahmudur Rahman Manna submitted nomination as an independent candidate in the constituency after the grand alliance gave ticket to businessman Akram Hossain.

In Bogra-5 (Sherpur-Dhanut), the 4-party alliance declared businessman Shafiuzzman Khakon, BNP leader Jan-e-Alam and BNP central leader and Sherpur town BNP president Mahabubur Rahman Hares as alliance candidates. Jamaat leader Rustom Ali also submitted

#### Rivals slate Akbar's Bargain on as JP visit to Delhi

Vow to resist him in Sreepur

Against the backdrop of move by party rivals in Sreepur upazila to resist visit of Dr MS Akbar, Awami League (AL) nominee for Magura-1 (Sadar and Sreepur upazilas) constituency, the of former lawmaker left for New Delhi on Monday.

"We are astonished to hear that Dr Akbar has left the country when BNP-led fourparty alliance candidate here is working everyday," said a Sadar upazila AL leader preferring anonymity.

Earlier on Monday, rivals of Dr Akbar in Sreepur upazila formed six teams to resist the former lawmaker's visit in the area.

### Grassroots leaders ignored as 8 new faces get BNP ticket

Selection follows 'suggestion' of jailed, absconding leaders

The BNP has fielded eight new faces, including three alternative candidates, for constituencies in Rajshahi and Natore districts mainly upon recommendations of jailed and absconding leaders while sidelining grassroots party men.

Three of the new faces are relatives of former BNP stalwarts who are either in jail or staying abroad being convicted in cases for abetting militancy and three BNP nominees are still facing corruption charges.

Former BNP lawmaker Abu Hena, who had earlier criticised those BNP stalwarts for their role behind militancy, has been dropped.

Before recommending party leaders for nomination, local unit leaders did not hold any grassroots leaders' meeting that was made mandatory in the Representation of People Order (RPO).

Rather, the local units followed recommendations of the jailed and fleeing leaders and sent names of their chosen persons to the BNP's central committee for party tickets. "The new electoral rules

made us optimistic about scope for creation of new leadership in the party. But the selections have made the new rules ineffective," said a deprived BNP leader. Among the new faces,

former inspector general of police Enamul Haque was given party ticket for Rajshahi-1 (Tanore-Godagari) constituency.

Enamul is brother of for-

mer BNP minister Aminul Haque, who went abroad after 1/11 changeover last year and later convicted in a case for patronising militancy. Several leaders of BNP and
