





I am extremely delighted that the Institute of Chartered Accountants of Bangladesh is going to organize an Award giving Ceremony to accolade the listed companies, NGO-MFIs and Public Sector Entities who were adjudged winners in the 8th ICAB National Award for Best Published Accounts and Reports 2007 competition.

Since 2001, ICAB has been organizing this event for best published accounts and reports annually. Both the 'preparers' and the 'users' have become encouraged to compete in the disclosure of more information in the financial statements since the inception of this venture.

The Institute of Chartered Accountants of Bangladesh (ICAB) through its Review Committee for Published Accounts and Reports (RCPAR) evaluates the annual reports of the listed companies, NGO-MFIs and Public Sector Entities under the guidelines set by the South Asian Federation of Accountants (SAFA) in this regard. The SAFA evaluation criteria encompasses parameters for Corporate Objectives, Chairman/CEO reports on CSR activities, environmental issues and statutory matters relating to governance and company affairs, Accounting and Financial Reporting Standards disclosures, stakeholders information, presentation and timeliness of reports/AGM. The RCPAR exercises stringent vetting procedures. The awardee companies have been selected through a process of fair and competent evaluation of all participating entities in an unbiased, objective and independent manner. This was a very challenging job and was performed with utmost sincerity and accountability. I express my sincere appreciation and gratitude to the RCPAR members, particularly to the

Evaluators for their dedicated contribution in the adjudication process.

I warmly congratulate the winners in the 8th ICAB National Awards for Best Published Accounts and Reports 2007. I hope that companies who could not win this year will participate in the next year's competition with better and improved annual reports.

What does the ICAB Award for Best Published Accounts and Reports stand for? It is certainly not a performance award. The awardees companies not necessarily are the best performing companies in their respective sectors. There may be companies whose top and bottom lines (in the income statements) grew at a much higher rate than the award recipients. The award does not signify that an awardee company is not a loan/dividend/tax/any other law defaulter/breaker. What are the distinctions of these companies which helped them to win this Award? Their disclosers and presentations of the stakeholders' information particularly on performances and prospects of their operations and corporate governance were better than others; disclosures were, in some cases, beyond statutory requirements. They disclosed their strategies and core values specifically to achieve their visions/missions. The winning companies published the annual reports precisely 'within time' with appropriate graphs and related photographs on stakeholders information. They disclosed about their efforts on caring for the mother earth and the society within which they operate and their contribution to the national exchequer. The awards therefore are recognition for the publicly disclosed financial and other corporate information and do not in any way represent any attestation by the ICAB for the operational performance, financial position, and capital adequacy and liquidity status of the compa-

What does the ICAB want to achieve by awarding these recognition if it does neither attest the quality of the information nor the performance? ICAB's objective is to create awareness in the corporate sector about the

value of timely publishing the audited financial statements as well as in disclosing the financial and non-financial information. ICAB believes disclosure of information in time will ultimately establish transparency and accountability in the corporate world and ensure the efficient use of resources and bring success to the business and thereby safeguarding the interests of the stakeholders in the long run. The ICAB BPA Awards is also expected to help improving the level of harmonization of Accounting and Financial Reporting Standards in Bangladesh with IFRSs and ISAs and thereby attracting foreign direct investment in the country.

However, the ICAB does not expect its award and evaluation anyway be used by anyone for any decision making (including for investment and /or raising funds). The user of the information, therefore, should not decide on the basis of ICAB's evaluation/award, rather should decide on the basis of the disclosed information in the annual reports.


From the SAFA/ICAB evaluation criterion, one may notice that only 35% of the disclosed information are audited, remaining 65% of the information/data disclosed in the annual report are not-audited. The credibility of these 65% of the disclosed information is dependent on the truthfulness and practice of accuracy of the management. It is high time that the Governments should amend the relevant laws to bring these information under the scope of statutory audit, as already done by some countries (e.g., information regarding corporate governance in Pakistan are to be certified by the statutory auditors.

The annual report of the 1st and 2nd position of the Awardee companies sent to SAFA Permanent Secretariat for competition amongst the companies in SAFA countries. Before sending nomination to SAFA Secretariat the ICAB evaluation criteria, process and results thereof was duly endorsed and attested by the Representatives of the Institute of Cost and Management Accountants of Bangladesh (ICMAB).

I am indeed profoundly happy and feel greatly elated to report that this competition is impacting a catalytic influence on the level of compliance and quality of financial reporting practices in Bangladesh. The competition has

improved the level of harmonization in financial reporting and auditing practices through implementation of IASs/IFRSs and ISAs/IAPSs, reflecting greater accountability of corporate management and credible transparency in published information. This induces rendition of relevant, reliable and comparable annual reports congenial to capital market development and industrialization of Bangladesh. This annual event of ICAB National Awards for BPA Reports has developed remarkable awareness for exuberant participation by contesting entities. This is evident from the fact that total number of participating entities for BPA awards competition are progressively increasing every year. I hope this trend will continue in coming years too.

I would like to express my sincere thanks and gratitude for the cooperation extended to the Institute of Chartered Accountants of Bangladesh by the participants and winners in the 8th ICAB National Awards for Best Published Accounts & Reports 2007 and the business community. Hope that our endeavour would make up a network that would integrate the Chartered Accountants with the business community for mutual benefits in the presentation of relevant and reliable accounts and information to the diversified stakeholders and other users.


