In a press release, membersecretary of the union of affected house owners Mohammad Abdul Hai said although the government gave them Tk 8.04 lakh per katha, this amount was very meager.

"We had submitted a memorandum to the chief adviser (CA) demanding our rehabilitation and following that he instructed Rajuk chairman and housing secretary to take proper steps in this regard, but Rajuk has not taken any step so far," he said.

# Pledge to reject war criminals in polls

The nation yesterday celebrated 37 years of liberation, saluting the valiant sons and daughters of the soil who made the supreme sacrifices in the Liberation War in 1971 for a modern and democratic state.

Thousands of people from all walks and ages across the country gathered at the memorials of the martyrs to pay tribute to the national heroes amid calls for trial of the war criminals and boycotting them in the national polls.

On this day in 1971, General AAK Niazi, chief of the Pakistani occupation forces, along with 93,000 Pakistani troops, surrendered to the joint forces of Mukti Bahini and Mitra Bahini in Dhaka following a miserable

Bangladesh proclaimed its independence on March 26, 1971 after 23 years of struggle for self-determination, bringing

Pakistani armed forces' genocidal wrath on its people the night before.

Pakistan army and their local collaborators Razakars, Al-Badrs and Al-Shams -launched a barbarous crackdown killing innocent people in the erstwhile East Pakistan at midnight past March 25, 1971.

The nation, under the paramount leadership of Bangabandhu Sheikh Mujibur Rahman, finally clinched independence on December 16 after the nine-month-long liberation

The day was a public holiday. The national flag was hoisted atop all government, semigovernment and other important establishments. The day was heralded by a 31-gun salute Memorial at Savar.

University's new admission conditions that disqualify Aleem graduates for their admissions to seven departments at the university. Upon a time prayer moved by Shadeen Malik, a lawyer for

Dhaka University authorities, an HC bench comprising Justice Mir Hasmat Ali and Justice Shamim Hasnain on Sunday fixed the date for hearing the matter. Following an application,

the same bench on December 2 stayed for four weeks the operations of the university's additional admission conditions disqualifying the Aleem graduates for their admissions to the departments of Bangla, English, International Relations, Mass Communication and Journalism, Economics, Women and Gender Studies and Linguistics. Earlier on October 26,

upon a writ petition filed by five DU admission seekers including Ibrahim Khalkil, who secured GPA-5 in Madrasa Education Board Examinations, the HC bench of Justices Syed Mahmud Hossain and Quamrul Islam Siddiqui issued a rule upon the Dhaka University authorities to explain why the new admission conditions disqualifying Aleem graduates for admission to seven departments should not be declared illegal. Barrister Belayet Hossain, a

lawyer for the petitioners, yesterday told The Daily Star that hearing of the writ petition will be held on Wednesday (today), if the matter is enlisted at the top stage of the day's cause list of the HC bench.
