Rebels worry grand alliance in 41 seats

The Awami League-led grand alliance is threatened with losing a lot of votes in at least 41 seats to the rebel candidates of alliance components AL and Jatiya Party (JP) in the December 29 parliamentary elections.

AL candidates have not yet withdrawn their candidature in at least 14 seats that have been kept for JP while rebel AL candidates have become a threat to alliance candidates from the ALitselfin at least 20 seats.

In three constituencies JP leaders are con- Zaker Party each from one seat. testing against alliance candidates from their own party while two AL leaders are contesting against the alliance candidates independently in two seats.

In Munshiganj-3 constituency, JP leader Mujibur Rahman is contesting the polls against alliance candidate Idris Ali of AL.

The grand alliance has kept three constituencies where both AL and JP candidates are contesting the polls as rivals.

Talking to The Daily Star last night, JP

Chairman HM Ershad blamed the AL for the situation. "Our opponents might get its benefit," he said in a resenting tone.

When contacted, AL election conducting committee co-chairman HT Imam said they would resolve the problem by today.

According to the seat sharing deal within the grand alliance, AL leaders were nominated for 242 seats and JP leaders for 49 seats including the three open seats, Workers Party leaders for three constituencies, Jatiya Samajtantrik Dal (JSD) for four seats and Gonotontri Party and

The three seats where the AL and JP are fighting as rivals are Nilphamari-4 with Shawkat Chowdhury of JP and Col (retd) Maruf Saqlain of AL, Khulna-3 with Abdul Gaffar Biswas of JP and Munnujan Sufian of AL, and Sylhet-3 with Atiqur Rahman of JP and Mahmud us Samad Chowdhury of AL.

Vote down corrupt, 'militants' patrons

Hasina urges voters HASAN JAHID TUSHER, from Faridpur

Awami League (AL) President Sheikh Hasina yesterday urged voters not to vote for the corrupt people, black money holders and patrons of terrorists and militants in the next parliamentary election.

"Soon after assuming power, the BNP-Jamaat coalition government looted crores of taka and siphoned off the money abroad which are now being revealed one after another," said the AL chief pointing finger to BNP Chairperson Khaleda Zia's son Arafat Rahman Koko who, according to the Anti-corruption Commission, has foreign currencies worth around Tk 11.43 crore deposited in a Singapore bank.

Hasina addressed several election rallies in the country's southwestern part before returning to the capital ending her four-day election campaign there.

Urging people to vote for honest candidates in the polls, the AL chief said now it is time to take a firm stance against corruption and terrorism.

She also pledged to protect the country from terrorism and

'Independent' judicial secretariat has to depend on ministry

The council of advisers to the caretaker government on Sunday gave the final approval to the ordinance, which is now waiting to be promulgated by the president, sources said.

According to the ordinance, the judicial service secretariat headed by the chief justice must go through the

law ministry to contact the president and the prime minister regarding any matter related to the functioning of

It means the chief justice will not be allowed to commuofficials as the ordinance nicate directly with the president or the prime minister regarding the secretariat's functioning.

Legal experts said the new ordinance is against the spirit of the judiciary's separation from the executive branch of government, with some of its provisions running counter to relevant articles in the country's constitution.

Article 116 of the constitu-

tion says the control including the power of posting, promotion and granting of leaves, of disciplining persons employed in the judicial service and the magistrates exercising judicial functions shall be vested in the president and

UPAZILA POLLS SCRUTINY ENDS

8,896 candidates declared eligible

The candidature of 8,896 aspirants for contesting the January 22 Upazila Parishad elections was cleared yesterday, the last day of three-day scrutiny of nomination papers.

A total of 9,976 aspirants submitted nominations papers to returning officers (ROs) and assistant ROs in 481 upazilas across the country.

Of the valid candidates, 3,699 are vying for chairmanship

while 3,173 for vice chairmanship (general) and 2,024 for the same position reserved for female candidates. The nomination papers of 1,080 aspirants -- 523 for chair-

manship, 370 for vice chairmanship (general) and 187 for the same position reserved for female candidates -- were declared invalid by returning officers. Additional deputy commissioners were appointed ROs while

upazila nirbahi officers worked as assistant ROs. The aspirants whose nominations have been cancelled will

be able to file appeal on December 20 and 21 with Deputy Commissioners (DCs) who have been given the appellate authority. The hearing of the appeals will be held on December 22 and 23.

The last date for withdrawal of candidature is December 31. Most of the aspirants are mid-level leaders of various political parties. If they get elected, they will have to quit party posts.

At least two BNP men were killed and eight others injured as a speeding truck ploughed through an electoral procession at Mominpur on Dhaka-Bogra Highway in Sherpur upazila of the district yesterday evening.

The deceased are identified as Abdul Majid, 44, and Mohammad Milon, 30, local leaders of Garidaha union unit of

Witnesses said the truck hit the crowd of BNP activists at about 6:45pm and fled the scene, killing two on the spot and injuring eight others.

Injured activists Shafiqul Islam and Mizan were rushed to Shaheed Ziaur Rahman Medical College Hospital in a critical condition while rest of them were taken to Sherpur Upazila Health Complex.

Angry BNP men damaged several vehicles and put up a barricade on the highway, disrupting traffic movement for about half an hour.

Sherpur police said they could not trace the killer truck as it fled from the spot immediately after the accident.


Mojahid earns around Tk 4.60 lakh annually while Nizami earns around Tk 1.80 lakh, according to the two top-ranking Jamaat leaders' wealth statements submitted to the Election Commission (EC).

Mojahid did not even give ownership of gold and other ornaments to his wife. However, he mentioned in his statement that those are actually his wife's.

He mentioned in the category of movable properties that he,

his wife and sons share Tk 1.51 lakh he kept in different banks and financial institutions. He has four flats. "Process is underway to transfer the ownership of three flats to my three sons and I will share the other one

with my only daughter," he said in his disclosure of immovable assets. His wife does not own any flats. As per the affidavit attached to his nomination paper, he has Tk 84,100 in cash and shares of two companies worth over Tk 5
