WAR CRIMINALS

Call to start process of trial immediately

'They can be tried under Int'l Crimes (Tribunals) Act'

War criminals can be tried under the existing International Crimes (Tribunals) Act, 1973, discussion yesterday.

"The process of the trial should begin immediately. Seeking help from the United Nations in this regard may delay the trial process," he

Bangladesh Heritage Foundation organised the discussion on 'Prospects and possibilities of transitional justice in Bangladesh, at Bilia auditorium where freedom fighters and university students were present.

Shahriar Kabir said there are enough evidence against the war criminals in the country. The trial process should start immediately, as the war criminals and their accomplices are destroying the proof of their involvement in criminals."

war crimes, he added.

He also said, "The war criminals and their accomplices are now carrying out militant attacks across the country and, at the same journalist and writer Shahriar Kabir said at a time, they are also threatening others. So, all should come forward to put them on trial."

Presenting the keynote paper, Tazrina Sajjad, who did her PhD from American University in Washington DC, suggested establishing a hybrid court comprising national and international laws and jurisdiction to try war

Political will is a must to try war criminals, as the issue has many political, social and psychological dimensions, she said.

Former Ambassador Wali-ur Rahman moderated the discussion. He said, "Involving the United Nations Security Council in the trial process would be one of the best ways to try war



Suhrawardi Hospital limping along on limited facilities

Relatives of a mason who had suffered a head injury were crying helplessly at the emergency ward of Shaheed Suhrawardi Hospital in the city where the attending doctor and nurses did not do anything except referring the patient to Dhaka Medical College and Hospital (DMCH).

They even did not provide any primary treatment to the patient who needed at least half an hour or more to take him to the DMCH, said the scared brother of the patient.

Motaleb, 32, fell from an under-construction building at Mohammadpur area and

received severe injury in his head. As the Suhrawardi Hospital is nearer to Mohammadpur, the relatives brought him to that hospital for quick treatment, but it only led to his delayed treat-

A significant number of patients who seek treatment at the emergency department of the hospital are referred to other hospitals, as the hospital is yet to be equipped with full-fledged emergency service facilities.

" Everyday on an average some 30 to 100 patients who seek treatment here are referred to different hospitals as we don't have enough facilities for treating them," said the on-duty Emergency Medical Officer Dr

"As wedon't have any CT Scan machinehere, we cannot provide service for patients with head injury. At the same time, due to lack of Intensive Care Unit (ICU) we have to refer them to other hospitals," he said, adding, "We just give primary treatment to the patients, and if necessary, we

admitthem to this hospital." But as there is no casualty, neurosurgery, neurology, paediatric surgery and cardiology departments, the hospital has to

It is also surprising that no emergency operation takes place in the 375-bed public hospital except the delivery for lack of manpower and surgical instru-Shortage of medicine at the

hospital also leads to continuous sufferings of the poor patients, and often the hospital can supply only 10 types of medicine at a time although it should have more than 70 types of drugs, sources said. Other facilities also were not expanded although the inflow of patients increased a lot inlastfewyears. The bed occupancy at

indoors increased from 73.92 percent to 76.91 percent in 2005 and 2006, which was mounted to 87.36 percent in 2008. But the number of doctors has not been increased since last 10 years.

A total of 192 doctors, nurses and class three and class four employees were recruited in 1997

and then some class three and

recruited in 2004, and since then no recruitment was made. At present the hospital is running with 97 doctors and 172 nurses. "Though we applied to health

ministry for some 160 registrars, assistant registrars and 100 medical officers along with professors, associate and assistant professors, nurses and technicians a few months back, we are yet to get any response from there," said the acting director of the hospital Prof Yakub Ul Azad, adding that, lack of manpower hampers the service in the hospital.

While visiting the medicine outdoor at 1:00pm, this correspondent found a large number of patients waiting since 9:00am, but they were yet to get the serial.

"Everyday nearly 400 patients come for treatment at the outdoor department of medicine ward, but there are only four doctors to attend them. It is not possible for a doctor to treat a hundred patients from 8:00am to
