50pc students won't get textbooks in 2-3 months

Printers allowed to do the job without tender

Around 50 percent of the students of classes VI to X of secondary schools who have already started their academic year this month will have to wait for at least two to three months more before they get Textbooks Board (NCTB). new textbooks for the current year.

Board (NCTB) has already put the first lot of the new textbooks on the market on January 6, with more to follow this month, but the number of books they ordered for print last year is almost one half of the actual demand in the country.

Meanwhile, following instructions will have to buy a new textbook this year. from the education minister yesterday, top NCTB officials held an urgent meeting with book printers and decided to permit publishers in the open market print the 14 main textbooks in order to tackle the crisis.

Teachers and printing agencies alike are blaming the situation on the indifference of the National Curriculum of the demand is higher.

The National Curriculum of Textbooks due to NCTB's failure to evaluate the syllabus has been modified? Around 4.10 actual requirement of new textbooks when the syllabus has been changed.

The syllabus has been modified this year and a new method introduced, namely the creative question method, for classes VI to X. As a result every student



UZ candidates' info to be made public

EC asks ROs to circulate their personal details, assets thru' leaflets

The Election Commission (EC) yesterday directed returning officers (ROs) to circulate several personal details of contenders in the January 22 upazila parishad election locally to help voters choose honest and competent candidates.

As per the EC directives, the ROs will circulate seven sets of information about the contestants. These include their educational qualification, profession, source of income, movable and immovable assets and liabilities of candidates and all their dependants, loans (if any)

and whether they are accused in any criminal case now, or were accused in any such case

All the 8,131 contestants for the posts of chairman, vice-chairman, and reserved vice chairman posts for women provided these information in the affidavit attached to their nomination papers submitted to the ROs and assistant returning officers (AROs). Of the candidates, 3,316 are vying for the post of chairman. 2,879 for vice-chairman and 1,936 for women's reserved vice-chairman posts.


SL massacre Zimbabwe
