# Rice to be cheaper

fertiliser and diesel price, said

The price of TSP (triple super phosphate) has been reduced to Tk 40 from Tk 75-80 a kg. MoP (muriate of potash) to Tk 35 from Tk 69-70 and DAP (diammonium phosphate) to Tk 45 from Tk 87-90, Agriculture Minister Matia Chowdhury said yesterday.

Last year, the average production cost of paddy was around Tk 11 a kg while the price of Urea was Tk 7, TSP Tk 40. MoPTk 35 and DAPTk 45 a

During the previous Boro season, the diesel price was Tk 40 per litre, which now stands at Tk 44 a litre. So the costs of agricultural inputs have not become cheaper than the last year's despite the new government's positive move, experts

Economist Zaid Bakht, research director of Bangladesh Institute of Development Studies (BIDS), said the government move would have a positive impact on rice price.

The production cost is going to come down," he said, adding that the production will also increase because of equal distribution of fertilis-

The government has reduced the price of non-urea fertiliser, which was out of the reach of the farmers who had been using only urea fertiliser. "Now it will help increase

the production," he said. Zaid Bakht also said the subsidy will not affect the budget which already has an allocation for the subsidy.

Dr Mahbub Hossain, the executive director of Brac, said the production cost of rice would decrease eight to 10 percent following the government move.

The farmers had stopped buying non-urea fertilisers after their prices shot up sharply. Now the farmers will be able to buy those again.

"Many farmers will use compost fertiliser instead of non-urea fertiliser," he added. Research Director of Centre for Policy Dialogue (CPD) Dr Uttam Deb said fertiliser prices on the international market doubled just after the last Boro season. But their prices started falling in November last year.

It is a proper government step for agricultural development, he said, adding, "If the government had not reduced the fertiliser prices, the production cost of rice would increase by over Tk 2.5 a kilogram," he added.

The experts said the government has to ensure supply of electricity in rural areas for running irrigation pumps in order to reduce the production cost further. Around 80 percent of total cultivable lands are under irrigation

A diesel-run pump now costs Tk 5,000 to irrigate an acre of land while an electricity-run one costs Tk 2,000.

At present, the government can meet one-fifth of the total electricity demand for irriga-

Following the directives from Hasina, who took over as prime minister on January 6, leaders of district, upazila and union units of the party moved to act accordingly. They tried to select one contender for chairman through mutual understanding, or if necessary, through secret ballots, in many upazilas. But their efforts failed.

In some cases, AL central leaders also intervened to resolve the discords but did not succeed due to uncompromising stance of the contenders in the polls, party insiders said.

Talking to The Daily Star yesterday, a senior AL leader seeking anonymity said many of the contestants did not agree to quit the electoral race hoping to 'get favour' in the polls as the party is in power.

Even in Pirganj upazila of Rangpur, from where Sheikh Hasina contested and own the recent parliamentary election, still has three AL candidates for the post of chairman.

The post is now very lucrative because it carries enough powers, and this why the contestants are not ready to quit the race, local leaders of the party noted.

Besides, now that the ALled grand alliance is in power, candidates expect party backing to ensure his her victory in the election, which is being held after more than 18 years. Upazila parishad chairmen

will carry out development activities using funds to be allocated to these local government bodies without consulting the local lawmak-

Despite efforts by senior field level leaders of the AL to

resolve the feuds centring the polls, clashes took place between supporters of rival party candidates in at least six upazilas in the last couple of

The upazilas include Boda in Panchagarh, Bagatipara upazila in Natore, Barisal Sadar upazila, Batiaghata in Khulna, Gouripur in Mymensingh and

Monirampur in Jessore. The clashes left over 50 party leaders and activists injured and party offices ransacked.

In many upazilas, although rival contenders from the AL stepped out of the polls race following intervention from party high-ups, they are not working for candidates who are backed by the party.

And rival candidates in many other upazilas refused to comply with grassroots leaders' decision to have one candidate for chairman. These upazilas include Kaliganj and Sreepur in Gazipur, Srimongal in Moulvibazar, Terokhada, Dighalya, Dakop, Batiaghata, Rupsha, Paikgachha, Fatullah and Koyra in Khulna, Sadarpur, Bhanga Nagarkanda, and Modhukhali in Faridpur and Sadar and Hatibandha upazilas in Lalmonirhat.

But in some districts like Chuadanga and Bogra, party leaders managed to place only one candidate for the polls race for upazila chairman.

"There is no problem in our district. Following the party chief's directives, we have picked a single candidate for the post in each upazila of the district," Chuadanga district AL General Secretary Abul Kalam Azad said when contacted over telephone.

Contacted yesterday Mansur Ahmed, vice president of Satkhira district unit of AL, said more than one candidates from the party are in the polls race in three upazilas out of seven in the district, ignoring the party decision.

# Koko kickbacks

Replying to questions following the US justice department's move to confiscate nearly \$3 million from bank accounts in Singapore, which are allegedly linked to a bribery scandal involving Koko, the US embassy spokesman said the US government is working closely with the Bangladesh government on the case.

DOJ filed a forfeiture action against the funds, held by multiple account holders, on January 8 in a US district court of the District of Columbia.

The accounts allegedly have the proceeds of a wide-ranging conspiracy to bribe public officials and their family members in Bangladesh, in connection with various public works projects.

The complaint relates primarily to alleged bribes paid to Koko, in connection with public works projects awarded by the Bangladesh government to Siemens AG, a German industrial conglomerate, and China Harbour Engineering Company.

When asked about the total amount of stolen money so far detected by FBI or DOJ in connection with the case filed, the spokesman said DOJ states that approximately \$3 million were traced by the US.

The US looks forward to working with the Bangladesh government to recover any additional amount that went through US financial institutions and are subject to the US jurisdiction, he said.

# Israel intensifies

The Islamist movement Hamas has reacted favourably to an Egyptian plan aimed at reaching a ceasefire in the Gaza Strip, an official source was quoted as saying yesterday by state news

"Hamas has reacted favourably to Egyptian efforts to end Palestinian bloodshed during discussions (in Cairo) over the last three days," the official was quoted as saying.

Meanwhile, three rockets were fired from southern Lebanon towards the northern Israeli city of Kiryat Shmona. The rockets fired from

Lebanon landed on open ground near the city. There are no reports of injuries or dam-Lebanese security officials

say the Israeli army fired eight shells into southern Lebanon in retaliation, the Associated Press news agency reported. Four rockets were fired on northern Israel from Lebanon

last week, prompting fears of a widening of the conflict. As attempts to end the crisis by diplomatic means continue, Israel pressed ahead with its military offensive overnight, hitting 60 targets, including 35

on the border with Egypt and a cemetery in Gaza City. However, analysts say Israel may be holding back from all-

implemented. Israel had planned to send its chief negotiator, Amos Gilad, to Cairo to meet with Ban, but the trip was cancelled. Meanwhile, the Israeli media have reported divisions

within the government. Defence Minister Ehud Barak is said to favour a weeklong ceasefire in Gaza to allow for the delivery of muchneeded supplies and to give politicians the breathing space to hammer out a long-term

truce. But Prime Minister Ehud Olmert says he wants to press on with the military campaign for however long it takes. After Cairo, Ban will visit

Israel and the West Bank as well as other regional powers. He has said he will also be encouraging initiatives to open border crossings with Gaza, which is subject to an Israeli

blockade, and provide humanitarian aid. The UN chief however is not scheduled to meet representatives of Hamas, but he has already held talks with Saudi King Abdullah amid reports Cairo is putting increasing pressure on Hamas leaders to

accept a truce proposal. A spokesman for Hamas, which controls Gaza, said any ceasefire agreement would have to entail a halt to Israeli attacks, a complete withdrawal of Israeli forces and the opening of border crossings to end the blockade of Gaza.

Humanitarian concerns have increased amid the fighting, although some aid is getting through to Gaza during daily three-hour lulls Israel has allowed to let in supplies.

On Tuesday, a senior UN aid official appealed to the international community to provide protection for civilians in Gaza, calling it a "test of our

humanity".

"Whatever is being done is not sufficient until the guns fall silent," John Ging said.

Since Israel's offensive on Gaza began on 27 December, nearly 1,000 Gazans have been killed, 4,400 have been injured, and an estimated 90,000 have fled their homes, according to Palestinian figures.

A UN watchdog has accused Israel of showing a "manifest disrespect" for the protection of children in Gaza.

More than 40% of those killed in Gaza were women or children, said the UN Committee on the Rights of the Child, even though Israel had signed a UN protocol condemning attacks on places where children were likely to be

present. Palestinian Authority President Mahmoud Abbas has accused Israel of trying to

"wipe out" his people. Meanwhile Bolivian President Evo Morales announced yesterday that Bolivia had broken off diplomatic ties with Israel in protest at its deadly attacks in the Gaza
