### Bank of America gets \$138b new govt lifeline

Bank of America, the largest US bank by assets, got a new government lifeline yesterday worth 138 billion dollars to help it absorb broker Merrill Lynch in another sign of the depths of the US banking

Conditions for the new aid include meeting strict restrictions on executive pay and compensation, and implementing a mortgage loan modification program, the US Treasury Department said in a joint statement with the Federal Deposit Insurance Corporation (FDIC).

News of the bailout rallied global stock markets on Friday after BofA saw its already weakened shares slide 18.4 percent to 8.32 dollars in Thursday trade on Wall Street amid concerns about the deal.

Market sentiment has been lifted ... after the US authorities announced plans to provide financial aid to Bank of America which has been struggling to digest the purchase of Merrill Lynch, said economist Lee Hardman at The Bank of Tokyo-Mitsubishi UFJ in London.

The Treasury said that it "will invest 20 billion dollars" in BofA from the Troubled Assets Relief Program (TARP) "in exchange for preferred stock with an eight percent dividend to the Treasury."

The Treasury and the FDIC will also "provide protection against the possibility of unusually large losses on an asset pool of approximately 118 billion dollars of loans, securities backed by residential and commercial real estate loans, and other such assets, all of which have been marked to current market value," the statement read.

The objective of this program is to foster financial market stability and thereby to strengthen the economy and protect American jobs, savings, and retirement security," Treasury said. BofA has already received

25 billion dollars (19 billion euros) in capital injections from the TARP, a US financial bailout fund set up to help rescue mostly banks reeling from financial turmoil triggered by a home mortgage meltdown.

That included 10 billion dollars for the investment brokerage firm Merrill Lynch, which BofA bought in a deal that closed January 1.

Israel on Thursday killed Hamas interior minister Said Siam, the most senior Islamist leader killed since the start of Operation Cast Lead on December 27.

Thousands attended his funeral Friday before marching through the streets with his body draped in a green Hamas flag. "With our souls, with our blood, We sacrifice for you Abu Musaab!" they said, referring to the Hamas strongman.

The war has sparked widespread protests and on Friday the Israeli army killed a 15year-old Palestinian teenager on the sidelines of a demonstration in the West Bank town of Hebron, medics said.

At least 1,143 Palestinians have been killed and another 5,130 wounded in the Israeli onslaught, according to Gaza medics. Some 600 civilians have been slain, including 355 children, they said.

Around 250 protesters then brought out a procession that paraded the street.

Sources said students and teachers from different city madrasas took part in the protest against the new khatib allegedly at the instigation of Islami Oikya Jote leader Fazlul Haque Amini.

Talking to The Daily Star, Amini, however, said, "I did not ask anybody to stage any demonstration against the khatib."

In reply to a question, he said, "Being a follower of Atrashi pir, Salauddin cannot be the khatib of the national mosque as most people will not accept him.

Salauddin told journalists that he is against any political activities in the national mosque.

In the first tender, Siemens was left off for technical noncompliance. The tender was however cancelled. The second tender in 2001 was also cancelled. After a change of government that year, BTTB floated the third tender that initially saw Siemens disqualified from the bidding.

The Supreme Court also directed the government to take immediate steps regarding issuance of Multi Purpose National Identity Cards to Indian citizens in northeastern Indian states that would help citizens to avail themselves of facilities like ration cards, school admission and inclusion of names in electoral rolls.

The bench noted that the Indian government in its affidavit filed in 2006 said that it planned to issue Multi Purpose National Identity Cards to citizens in the border states and create a National Identity of Register.

The court also referred to the government's statement on fencing India-Bangladesh border in two phases and wanted land acquisition for fencing to be completed at the earliest.

"All of a sudden, the captain came on and said, 'Brace for impact' and that's when we knew we were going down, into the water. And we just hit know, stayed afloat and we were all able to get on the raft now that everybody's still as inhumane. alive."
