# Govt leans on advisory clout

Amends rules of business to allow PM to appoint as many advisers as she wants

The new government has amended its rules of business, empowering Prime Minister Sheikh Hasina to appoint as her advisers and special assistants as many persons as she deems nec-

The amendments authorise the premier to determine the terms and conditions of the appointments as she deems expedient in public interest, and also allow her to let any of the advisers or special assistants attend meetings of the cabinet or any other government committee.

Exercising his constitutional authority, President Iajuddin Ahmed on Thursday brought the amendments to some sections of the rules of business, sources in the cabinet division said.

Prime Minister Sheikh Hasina has already appointed to herself six advisers with the ranks and status of full-fledged ministers.

Highly placed sources in the government told The Daily Star on Saturday that Hasina, also the president of Awami League (AL), is expected to appoint a few more persons as her advisers.

On functions of the advisers and special assistants, the new provisions say the prime minister may seek advice and assistance from them on any subject.

An adviser or a special assistant will also be obliged to carry out any special task assigned to him or her by the prime minister from time to

Speaker says constitution to be amended

Newly elected Speaker Abdul Hamid said yesterday the government will soon place a bill in parliament to amend the constitution to create a second post of deputy speaker, who will be elected from the opposition.

BNP, the major opposition party in the House, however said they will not propose anyone for the post that will require amending the constitution.

Senior BNP lawmaker Salauddin Quader Chowdhury told The Daily Star yesterday that they would not accept the post of deputy speaker (to be created). "BNP is not in such a distressed condition that it will have to take donation like VGD (vulnerable group development)," he said.

# Second deputy speaker from Telegraph scripts trouble

Offices of the obsolete technology spend 15 times their earnings; ACC asks BTCL to shut all offices soon

The Anti-Corruption Commission (ACC) recommended Bangladesh Telecommunications Company Ltd (BTCL) to permanently close all its telegraph offices after a probe revealed that expenditure of the almost idle and corruption-riddled offices were 15 times their income between 2000 and 2008.

The investigation found that even though telegraph is hardly used nowadays, there are about 3,500 people employed in 450 telegraph offices in the

A number of employees are involved in abusing power and corruption causing a huge loss of government money, the ACC said.

The probe also revealed that during the eight years each telegraph office on a monthly average received and distributed telegrams worth only Tk 200.

It was found that in the eight years the telegraph sector under BTCL--former BTTB--earned about Tk 2 crore and spent Tk 29.76 crore in operating cost. The

investigation disclosed that a large chunk of this money was misappropriated through various illegal means and cor-

There has been hardly any work at telegraph offices after 1999 when mobile and internet technology started spreading fast. Most countries in the world do not use telegraph anymore. Only ships use it as a last resort of communication.

"In reality, the people employed in telegraph offices do not have any work. And the little work that is done does not require fulltime employment of so many," ACC Director General Col Hanif Iqbal told The Daily Star yesterday.

"The government can use this man-

power in other service sectors," Hanif

He said corruption in telegraph offices is still under investigation and action will be taken as per law against people involved in illegal activities.

The telegraph offices only deal with a few telegraphs made by a number of banks. Government and a few private office employees also use telegraph when they need to extend their leave as telegraph provides evidence of their communication with their offices, the ACC investigation found.

Of the total 29.76 crore spent by telegraph offices, Tk 87.14 lakh was spent under office contingency during the eight years.

CORRUPTION

Officials of telegraph offices showed that they had to pay Tk 83.70 lakh in electricity bills against an allocation of Tk 82.87 lakh. However, the investigation found that only Tk 6.52 lakh was actually paid for electricity and the rest Tk 77.17 lakh was misappropriated under the cover of repair works and purchase of materials.

## BNP wants Iajuddin to be impeached

The main opposition BNP wants to see President Iajuddin Ahmed impeached for 'violating the constitution by failing as the chief adviser to hold the parliamentary polls within the stipulated 90 days'.

Policymakers of the ruling Awami League (AL) however do not subscribe to the BNP's views on grounds for the possible impeachment.

They think the president had 'flouted the constitution by assuming the chief adviser's role' in the first place.

Against this backdrop, the Election Commission (EC) yesterday informed Speaker Abdul Hamid about its plans to hold the presidential election on February 18 as Iajuddin's tenure had long expired, sources in the EC said.

The commission will unveil the formal schedule once it has the speaker's consent. If the election is not uncontested, the House will be the polling venue, added the sources.



## EC yet to act on complaints

## More upazila poll objections poured in

The Election Commission (EC) Secretariat continues to receive complaints from defeated upazila election candidates but the commission is yet to work out a procedure to investigate those, and go for the next course of action.

Of the two complaints it received yesterday, one is against state minister Dipankkar Talukder and the other concerns ruling Awami League (AL) lawmaker Kamal Ahmed Majumder.

In the last two days, the EC Secretariat got over 100 complaints from defeated contestants stating that ruling Awami League (AL) lawmakers and activists influenced voting, intimidated voters and stuffed ballot boxes after beating up and driving out their polling agents.

Three defeated candidates for the post of chairman in Kawkhali upazila of Rangamati jointly filed a complaint that said Dipankar Talukder influenced the local administration during the January 2 upazila parishad elections.

Influenced by the state minister, the local administration refrained from taking any action against AL activists although they intimidated voters and threatened to drive them out from the area if they do not vote for AL-backed chairman candidate
