

Kibria's role recalled amid recession

The country badly feels the absence of economist Shah AMS Kibria at a time when the global economic meltdown is shaking the world, speakers said at a discussion in the city yesterday.

Speaking at the Kibria memorial speech at the National Museum marking the fourth death anniversary of the former finance minister, they demanded punishment to the killers of Kibria.

"By his commitment and brilliance, Kibria strengthened the country's economy as a finance minister during 1996-2001. The inflation rate hovered around two percent at that time," said Finance Minister AMA Muhith.

He hoped that the government would be able to punish the killers of the former finance minister.

Two ministers and an adviser to the prime minister Tuesday visited Barapukuria coalmine area and held a meeting with villagers affected by land subsidence in the area to discuss rehabilitation and compensation issues.

Prime Minister's Adviser Dr Towfiq-e-Elahi Chowdhury, Environment Minister Mustafizur Rahman and State Minister for Energy Shamsul Haq Tuku held the open discussion.

The meeting started in the evening and ended at 9:00pm. The adviser and ministers, later, held another meeting with the Barapukuria Coal Mine Company Ltd (BCMCL) officials that continued till 11:00pm.

Sources said that they discussed with villagers issues related to land subsidence, loss of arable land and sufferings of people caused by the coalmine project.

NBR to unfreeze 45 bank accounts

Evaded tax, fine to be deducted

The National Board of Revenue (NBR) is likely to allow reactivation of 45 out of 309 frozen bank accounts primarily after deducting the tax evaded by the account holders and 10 per cent

Sources said the NBR will give directives to the tax commissioners concerned after having discussions with government high-ups on the matter.

During the tenure of the immediate past caretaker government, 335 accounts of both Awami League and BNP leaders and businessmen were frozen. Of those, 26 accounts were reactivated at different times.

NBR is seeking guidelines from the government high-ups on the rest 309 accounts.

Anti-corruption task force had conducted investigation and submitted 119 reports on the bank accounts before its abolition on January 1, NBR sources said.

It will ask the tax commissioners concerned to find out the amount of tax evaded by the account holders and take necessary steps about the accounts on which task force reports are available but no case has been filed. There are about 45 such

MADRASA STUDENTS SC upholds HC order on DU rules

departments. The four-member full bench of the Appellate Division headed by Chief Justice MM Ruhul Amin passed the order rejecting the DU's petition for staying the HCjudgement.

The apex court also asked the DU authorities to file a regular appeal with this court against the HC judgement after getting certified copy of the verdict.

them to attend the meeting with the chairperson. According to the plan chairperson will talk to the leaders of party's upazila units to get the true portrait and recent activities of grassroots level leaders. She will also enquire about the activities of the district committee leaders.

The chairperson may take actions against any of the district committees that has failed to do their respective duties properly immediately after the discussion with the field level leaders," a central leader said.

The district level leaders, however, said they were yet to get any such directive from the party high-ups regarding the organisation revamping process.

ILLEGAL MIGRANTS IN THAILAND

Barefoot 62 fail to pay fine, land in jail

A Thai court yesterday convicted 62 barefoot, disheveled migrants detained at sea of illegally entering the country, raising the prospect they could be deported despite fears they could face persecution or death if sent back to Myanmar.

A Ranong provincial court judge fined each defendant 1,000 baht (\$30) a sum that none of them could produce. So he sentenced them to five days in prison.

migrants on Monday after their rickety boat was found adrift in the Andaman Sea off Thailand's southwestern coast.

The Thai government contends the

migrants do not qualify for refugee status, and a police official said they would be turned over to immigration police after they served their sentence and could be expelled.

"Have pity on us," migrant Mamoud Hussain said before the ruling at the provincial Ranong Courthouse.

"They'll kill me and my family if I go back." Hussain, 50, was among 78 migrants on the boat. Four others were hospitalized. Twelve minors were being held separately by immigra-The Thai navy detained the Rohingya tion police because they are too young to be tried in the court, said Ranong police Col Weerasilp Kwanseng.

SHIP BREAKING INDUSTRY 7,000 child labourers doing hazardous job

Nearly a quarter of the total workforce in the ship-breaking industry in Chittagong is child labourers who are primarily used for the more hazardous jobs at the yards, a survey of two NGOs revealed this yesterday.

Young Power in Social Action (YPSA) and International Federation for Human Rights (Fidh) in the jointly prepared report, with technical support of NGO Platform on Ship Breaking, said at least 7,000 workers in the industry are below the age of 18.

Around 30,000 workers are employed in the ship-breaking yards of Chittagong.

US middleast envoy George Mitchell arrived in Israel yesterday after saying it was critical to consolidate the Gaza ceasefire, as

tensions rose after a deadly raid by Palestinian militants. He flew into Israel from Egypt on the second leg of his maiden trip to the region, instructed by President Barack Obama to "engage vigorously" in order to resuscitate the lifeless Israeli-Palestinian peace process.

"It is of critical importance that the ceasefire be extended and consolidated. We support Egypt's continuing efforts in that regard," he said after meeting Egyptian President Hosni Mubarak.
