JAGANNATH UNIVERSITY

Grabbers occupy all 12 dorms for years

Twelve dormitories of Jagannath University have long been under the occupation of former lawmakers, leaders of Chhatra League and Chhatra Dal, local criminals and even government organisations like the Dhaka City Corporation (DCC) and police.

The DCC authorities have leased a hostel of the university from the deputy commissioner for building a school while former Awami League lawmaker Haji

Selim built a market in his wife's name occupying part of another hostel illegally. Families of policemen have been living in four of these hostels.

Many of these illegal occupants have even prepared fake documents of their ownership of these university dorms.

Students of Jagannath University have been moving to get back the hostels, which recently ended up in clashes between police and students and closure of the university for indefinite period.


Sources alleged that a few leaders of

Bangladesh Chhatra League (BCL), who receive shares and tolls from different markets and shops of the illegal occupants of these hostels, opposed the movement by the general students.

Haji Selim built multi-storey Gulshan Ara City Market in his wife's name occupying a part of Tibet Hostel at Wiseghat. The other part of the hostel is occupied by the families of a few policemen.


When contacted Haji Selim refused to talk to The Daily Star on the issue.

Several central and local leaders of BNP are aspiring for party nomination for contesting parliamentary by-election to two Bogra seats vacated by party Chairperson Khaleda Zia.

A section of BNP leaders have started lobbying for party ticket for senior central leaders while district level leaders expect the party leadership will nominate candidates from among them considering local people's sentiment, party insiders said

Khaleda Zia, who won three seats in the December 29 parliamentary election, retained Feni-1 seat and vacated Bogra-6 and Bogra-7 seats before taking oath as lawmaker on

Step to prevent war criminals from fleeing country

The Ministry of Home Affairs has asked the authorities concerned to guard all points so that no war criminals can flee the country, said Home Minister Sahara Khatun yesterday.

"All relevant information about war criminals has already been sent to respective places," she told journalists after attending the 23rd Annual Conference of Bangladesh Law Association (BLA) at Kazi Motahar Hossain Bhaban in Dhaka University (DU).

Replying to a query, the home minister said the recent incidents like murder of a businessman and stabbing of a DU student are being looked into seriously. "I ordered arrest of the criminals involved in the incidents."

4-PARTY STANCE ON WAR CRIME TRIAL

None but IOJ to side with Jamaat

Jamaat-e-Islami is virtually isolated in the fourparty alliance on the issue of trial of war criminals as two of its three other partners are keeping their distance from the religion-based

Supporting a transparent trial of war criminals, the BNP and Bangladesh Jatiya Party said it is Jamaat that has to face the situation.

Jamaat leaders admitted that they are unlikely to receive any support from others on the issue.

IN REMEMBRANCE

Bapex finally breaks free from Motive for Lalbagh red tape, to buy €20m rig

Bangladesh Petroleum Exploration Company (Bapex) has outwitted a fiveyear-old vicious cycle of bureaucratic bottleneck to procure a drilling rig for 20 exploration capacity.

After four rounds of failed tender bids since 2004, Bapex succeeded in its fifth round tender opened in April last year.

On January 20, the company finally signed a deal with Sichuan Hong Hua Petroleum Equipment Co (Shhpec) of China to supply a "2000 HP" rig along with accessories. The sophisticated parts of the rig would come from west Europe and the US and the rest from China.

We expect the rig well before the end of 2010," says Muhammad Imaduddin,

managing director of Bapex.

While it now produces a paltry 40 million cubic feet gas per day (mmcfd), Bapex's production is set to grow up to 140 mmcfd from 2011.

During that time, Bapex as the counmillion euro to expand its oil and gas try's lowest cost operator is expected to be involved in several drilling programmes for itself and as contractor for other companies operating in the country and thus help increase local gas production.

All the four previous bids to purchase the rig, except the first one, fell flat because every time Bapex floated a tender, the lowest price offer turned out to be 20-30 percent higher than the government approved budget.

Each time Bapex went back to the authorities and returned with a revised budget the price offers in the next tender

turned out to be higher than the revised budget. Each re-tender process was claiming a year's time. Just when this was becoming a perpet-

ual cycle, Bapex did something different to break the vicious cycle. "This time we went for the fifth re-

tender without revising the budget first," Imaduddin said. Typically the tender evaluation pro-

cess for selecting complicated equipment like a drilling rig needs three months. Bapex utilised these three months for fixing a new budget on the basis of the initial impression of the price offers submitted by six bidders. This revised budget was sent to the Executive Committee on National Economic Council (Ecnec) for approval within three SEE PAGE 2 COL 5
