

Obama's economic recovery plan on track in Senate

AP, Washington US President Barack Obama's economic recovery plan is on track to pass the Senate after a handful of moderate Republicans and Democrats forced more than \$100 billion in cuts in programs that wouldn't create many jobs right away.
