Wasa plans to pump water into sewer lines to flush out bodies

The sluice gate of a sewage line from BDR headquarters turned into a hole for the dead as more bodies of BDR officers killed in Wednesday's mutiny floated out of the gate at Nawabganj Bazar yesterday morning.

Eight bodies--two on Wednesday and six yesterday--were found near the sluice gate in Hazaribagh.

Dhaka Water Supply and Sewerage Authority (Wasa) plans to pump water into the sewage lines from inside BDR headquarters to flush out bodies if any are still trapped inside.

It had initially deployed a team to search for bodies at the sluice gate but later withdrew as there was little they could do from that end.

Meanwhile, relatives of missing army personnel rushed to the spot around Wednesday noon as soon as they heard about the bodies. Six other bodies had floated out to the same place by 9:00am yesterday.

The bodies discovered yesterday were identified as those of Lt Col Kamruzzaman, Lt Col Anisuzzaman, Maj Mahbub, Col Zahid, Col Tauheed and Captain Mohammad Majharul Hayder, SEE PAGE 2 COL 5

Search goes on for the missing

Relatives of missing army officers continue to search the city hospitals frantically for their loved ones.

Khairul Anam, brother of an army major, enquired the wounded Bangladesh Rifles (BDR) members at the Holy Family Red Crescent Hospital whether they knew anything about his missing brother yesterday.

"We heard his voice over the telephone last time at about 12:00noon on Wednesday. He said 'I am in danger, cannot talk now. 'We lost track of him since then," he said.

His brother moved to the BDR headquarters along with his wife and their three-month old son who remained confined there, said Khairul, who had earlier searched the Combined Military Hospital and several other hospitals for his brother.

Meanwhile, some 17 BDR members with bullet wounds were shifted to the Holy Family Hospital from the BDR Hospital. They are Jahangir, Hazi Mir Masum, Deputy Assistant

Director Kader, Anwar, Abdul Aziz, Babul, Golam Shahin, Mahbub Alam, Mohsin, Masum Billah, Mosleudddin, Abdul Jalil, Havildar Rafiqe, Abul Kalam, Nurul Huda and Shahjahan.

"The condition of two BDR men is critical. They have been kept at the Coronary Care Unit. We have referred another to the National Institute of Diseases of Chest and Hospital on Wednesday night after he complained of chest pain," said SEE PAGE 2 COL 8

They line up to seek peace

Most malls in Dhaka run without fire safety

Most of the markets and shopping malls in Dhaka are running without adequate firefighting equipment, keeping at stake life and property of owners, tenants and customers.

The Fire Protection Act, 2003 directs all the buildings including the commercial establishments to have sufficient firefighting equipment and conform to measures of public security.

However, most of the commercial buildings, especially the old markets, don't have enough safety equipment, emergency exits and sufficient space between adjacent buildings. Experts say if such a building is in fire, the flames can spread rapidly to neighbouring structures.

A fire broke out on the ground floor of Madina Traders, a chemical shop at Yakub Super Market opposite to Gausia Mart on February 20. Before firefighters doused the flames, the fire caused a loss of Tk 17.8 crore, say owners of the market.

As many as 56 shops were burned down during the fire, which is the latest example of neglect in adopting fire safety measures.

Another fire broke out on February 14 on the fourth floor of Annexco Tower in Fulbaria, very close to the head office of Fire Fighting and Civil Defence. Owners of six warehouses at that market suffered around Tk 15 lakh loss due to the blaze, they inform.

Mutiny halts exams, other US sees rights problems in South Asia

The United States on Wednesday reported widespread human rights violations across South Asia but also noted glimmers of hope thanks to political transitions in Pakistan, Bangladesh and In an annual report on human rights, the State Department

said abuses remained rife in South Asia with major problems in the treatment of women in much of the region. But the report saw progress as Pakistan shook off military

rule, Nepal's insurgents transformed into a ruling party and a caretaker government guided Bangladesh into elections. Bhutan and Maldives also witnessed dramatic changes. "There were several improvements with regard to elections

and political competition in South Asia," the study said. The State Department said that Pakistan -- a frontline ally in

the US "war on terror" -- had a poor human rights record due to extrajudicial killings, torture and disappearances. But the report said the number of politically motivated disap-

pearances declined last year, during which military leader Pervez Musharraf -- who had imposed a state of emergency -stepped down. It saved some of its harshest criticism for Pakistan's prison

system, which it called "extremely poor" with serious overcrowding, inadequate food and frequent abuse of non-Muslim
