headquarters. Another officer concerned said some 451 rebels stayed put at Pilkhana after laying down arms in response to the prime minister's general amnesty, but the rest 6,750 escaped.

"Those who surrendered on announcement of the amnesty have been kept in BDR hospi-

tal," he continued. Following the government notice for them to report for duties within 24 hours ending at 4:00pm on March 1, around 6,500 BDR men returned to the

headquarters. "Around 250 border guards who did not get back to barracks yet will be considered deserters," noted the officer.

Around 6,500 BDR troops who had fled despite the amnesty but later joined in response to the 24-hour notice will be considered to have been 'absent without leave', he added.

According to rules and regulations of the force, they will face minimum 15 days' rigorous imprisonment and maximum 28 days' for absence without permission.

Sources said the BDR DG can hand down an offender up to seven years' rigorous imprisonment for grievous offences like mutiny. If those at large return they

will face departmental actions both for not joining in time and mutany. The officials are preparing a

detailed list of border guards who were inside the headquarters during the mutiny and from where they came.

"Of the 7,500 troops, more than half were from battalions based in Dhaka. Some of them were staying at Pilkhana as it was their station, while some were there for training and other purposes," said an army officer.

the capital. "We are working to draw up separate lists of those who were in Darbar Hall when the mutiny began and those who were inside the compound at that time," he added.

They are also making lists of weaponry to know the volume of firearms and ammunition mutineers used in the butchery and took away while fleeing.

Meanwhile, the BDR DG told The Daily Star that families of those who have reported back in compliance with the government's instructions need not worry.

He said it would take some time to create order and control in BDR whose system has suffered a huge shock.

"The troops and their families will surely get their salary and rations. We are trying our best to ensure those for them as soon as possible."

DG Mainul urged all staff of the border force to cooperate in the investigation and efforts to hunt down the culprits in the

Lashkar has denied involvement in the carnage in Mumbai.

Chidambaram told Pakistan it must fully dismantle "the terror infrastructure" in the country, saying large swathes of Pakistan were under Taliban control.

be tried and punished. However, according to the legal experts, the highest punishment against the offences under these laws is death penalty.

Talking to reporters after inauguration of basic training for new assistant judges and judicial officials at Judicial Administration Training Institute (JATI), he said the disposal of Bangabandhu Sheikh Mujibur Rahman murder case is at the final stage at the Appellate Division of the Supreme Court.

The chief justice will take necessary steps for constituting a bench of the apex court for hearing this case after the attorney general's office submits a prayer, he said.

Shafique Ahmed said if the paper book on this case is readied, it will not take too much time for disposal of Bangabandhu murder case.

He said the International War Crimes Tribunal Act enacted by the Bangabandhu government in 1973 for trying the criminals involved in the offences against humanity and committing genocides, rape and torture against the country's people are still in force and if it is proved that such crimes were committed during the BDR mutiny, the criminals will be tried under this law.

The constitution will have to be amended to constitute the special tribunal for trying the culprits of Pilkhana but all things regarding the trial will depend upon the investigation, the law minister said.

Presided over by JATI Director General Justice Hamidul Huq, the meeting was addressed, among others, by its director Md Ashraful
