DCC ELECTION Khaleda demands Tk 5 crore for party backing

Claims mayor aspirant Irad Siddiky

Irad Ahmed Siddiky, a Dhaka City Corporation (DCC) mayor aspirant, yesterday alleged that BNP Chairperson Khaleda Zia demanded Tk 5 crore from him in exchange for party backing in the upcoming mayoral election.

During a press briefing at his Gulshan home, Irad Ahmed, in presence of his father BNP standing committee member Tanbir Ahmed Siddiky, said, "I met the BNP chairperson and she wanted to know if I had enough money. I told her that honest and competent candidates are not supposed to have enough money. She said 'I would be very frank' and then that I will not give her the money from my bank account since I am neither Mosaddak Ali Falu nor Mirza Abbas."

Refuting this allegation, BNP Chairperson's Press Secretary Maruf Kamal Khan Sohel vesterday told The Daily Star, "This is absolutely baseless, false and narrow-minded propaganda against Khaleda Zia."

'He [Irad] is not of BNP and he has no right to seek party nomination. He is spreading the propaganda using the privilege of being the son of a BNP leader. This is why the media should not encourage such defamatory statements made against a former prime minister," Maruf

Irad during the press briefing also said, "I am ready to accept the BNP ticket if it decides to give it to me but the BNP chief should know that I will not be servile to any dynasty."

He said, "They [BNP] will prove themselves to be a party with vested interest if they do not nominate me...it will prove that they are not interested in the welfare of Dhaka city, rather interested in grabbing power."

Coming down heavily on former DCC mayors Mohammad Hanif and Mirza Abbas and incumbent Mayor Sadeque Hossain Khoka, Irad said all of them have failed. "How does a responsible political party nominate people like Mirza Abbas, Sadeque Hossain Khoka or Hannan Shah who has

acorruption record?" "If BNP nominates these people, it will be bad for the country. I want to contest the mayoral election to change the traditional politics and nonpolitical issues should be focused on in the mayoral elections, "he said.

Irad also announced his candidature for the DCC may-

"I will be a BNP-minded independent candidate," he said. He also said there are two

streams in BNP -- one is 'Zia stream' and the other is 'Khaleda stream'. "I want to be a BNP-minded candidate of the 'Ziastream'." Later, he distributed a 76-

point election manifesto and explained some of his plans to turn Dhaka into a beautiful digital city.

When asked about Irad's allegation, his father Tanbir Ahmed Siddiky said, "Madam [Khaleda Zia] said at least Tk 5 crore will be needed for the election as there are 15 constituencies in Dhaka. It was a private discussion and he should not have disclosed it in public."

Tanbir also said Irad lacks political acumen and he is a simple-minded person but he is "a highly-educated expert and researcher"

3 get 30 yrs' RI for possessing heroin

A Dhaka court yesterday sentenced three people to 30 years' rigorous imprisonment for possessing 3.5kg of heroin in January in 2001.

Judge Mohammad Abu Mohsin of the Fifth Additional Metropolitan Sessions Judge's Court handed down the sentence in presence of the convicts. The convicts are Harunur Rashid, Mohammad Mazharul Hossain and Kazi Zafar Reza.

Earlier, the prosecution and the defence had completed their arguments and the court recorded statements of 19

prosecution witnesses. According to the prosecution, three convicts, proprietors of M/S Turag Enterprise, carried four baskets of vegetables at Zia International Airport for export purpose at 4.00pm on January 22, 2001. But the customs officials searched those baskets and seized 3.5kg of heroin. They also arrested the three for possessing the heroin. A case was filed with Cantonment Police Station in this connection the same day.

The investigation officer pressed charges against the three on May 29, 2001.

Law minister exempted from proceedings of writ petition

The High Court (HC) yesterday exempted Law, Justice and Barrister Shafique Ahmed from the proceedings of the writ petition claiming that he (Shafique) was simultaneously holding posts of the minister and member of Bangladesh Bar Council

As the Attorney General and also ex-officio chairman of Bar Council, Mahbubey Alam yesterday informed the court that Shafique Ahmed had resigned from the post of the Bar Council member on January 6 before taking oath as minister, the HC released him from the petition.

ABM Nurul Islam, a senior lawyer of the Supreme Court, filed the writ petition stating that he (petitioner) has received the next highest number of votes in the Bar Council election and he should have been invited to fill up the post that fell vacant after Shafique Ahmed took over as the minister.

The HC bench of Justice Syed Mahmud Hossain and Justice Quamrul Islam Siddiqui, however, issued a rule upon the Bar Council chairman and secretary to explain within two weeks why the petitioner should not be recognised as a member of the council in the absence of Shafique Ahmed.

In the petition filed on March 5, the petitioner said as per Article 12 of Bangladesh Bar Council Order 1972, if any elected member of the Bar Council assumes another office of the government or any statutory body, the post of that member will be casually vacant and the candidate, who received the next highest number of votes in the Bar Council election, will be entitled to be the member.

According to the petition, Nurul Islam is the receiver of the next highest number of votes in the election and he (Islam) should be entitled as a member of the Bar Council in the absence of Shafique Ahmed as per the law.
