"Executive magistrates will exercise the authority till the cases are ready for trial," he said adding that judicial magistrates will still be able to complete the trial proceed-

Meanwhile, representatives of police association demanded scrapping of the district executive magistrates' authority to take certain decisions on law and order in the metropolitan cities.

They said in the previous law the power was delegated to police commissioners.

The committee assured the police association of consider-

ing their demand. Referring to the opinion of the three associations, committee Chairman Suranjit Sengupta said the bill, now under scrutiny, would be modified for the sake of a dynamic administration.
