

SC asks for security

The Supreme Court (SC) authorities have requested the government to take immediate steps to ensure security on the court premises.

In letters sent to home and law secretaries and inspector general of police on March 11, the SC Registrar's Office said judges, lawyers, litigants and staff at the apex court have been "feeling insecure under the present circumstances".

Mentioning deaths of several people including judges and lawyers in militant attacks in the recent past, the letter says the government should make foolproof security arrangements including deployment of additional police at the courthouses.

BDR jawan dies, 7 others hospitalised

A Bangladesh Rifles (BDR) member died yesterday at Pilkhana and seven other BDR personnel with 'various diseases' were admitted to Dhaka Medical College Hospital (DMCH).

The BDR man who died was identified as Sepoy Monir Hossain, 32.

Earlier, two BDR members allegedly committed suicide—one at Pilkhana and the other at Joypurhat BDR barracks—while the pesh imam of BDR headquarters mosque died of a cardiac arrest during interrogation over the carnage and mutiny at Pilkhana.

Ship-breaking ordered shut

HC gives 2 weeks for closure as none of 36 yards has environmental clearance; asks govt to ensure no toxic ship enters territory

The High Court has directed the government to close in two weeks operation of all ship-breaking yards for running without environmental clearance.

None of the existing 36 ship-breaking yards, which are identified as category Red (extremely dangerous), has taken or applied for environmental clearance from the government, reveals a report submitted to the court by the Department of Environment.

The HC considering the country's environmental degradation also ordered that no ship would enter Bangladesh territory for breaking without cleaning its hazardous materials at source or outside the territory.

The HC bench of Justice Md Iman Ali and Justice Sheikh Abdul Awal gave the directives following a writ filed by Bangladesh Environmental Lawyers Association (BELA).

The court also clearly imposed a bar on any Greenpeace listed toxic ship's

entry into the waters of Bangladesh.

The court ordered the DoE to implement the directives within two weeks from receiving the order and directed the government to form a committee to monitor the implementation process.

As per the HC order, no ship-breaking operation will take place from now on without environmental clearance. The government has to ensure that ships are broken after safe working condition for the workers is guaranteed and shipyards

Killer of Gen Shakil, 2 others identified

Investigators so far find 650 involved in BDR carnage

At least three of the detained BDR men were among the mutineers who gunned down their DG Maj Gen Shakil Ahmed and some other senior army officers at the Pilkhana Headquarters.

The three have been identified by suspected mutineers now being grilled at the Taskforce for Interrogation (TFI) Cell. The BDR men claimed a group of six to seven who first opened fire at the Darbar Hall were riflemen, not outsiders.

"None has so far revealed the names of the initial shooters during interrogation, though it seems they know them," said a top law enforcement tasked with investigation into the carnage.

He however hopes they will get important breakthrough once the shooters are identified

and quizzed.

"We've identified the killer of BDR DG Maj Gen Shakil Ahmed and at least two others who gunned down other senior officers," said the investigator speaking anonymously.

He however did not reveal the names of the three now in custody.

They have earlier arrested the BDR jawan who killed the wife of Maj General Shakil, he added.

The investigator also said they have so far detected around 650 riflemen who had involvement in the mutiny.

Those mutineers have been detected through examination of video footage, interrogation of arrested jawans and from the statements of the survived officers and family

CHINA HARBOUR, SIEMENS ACC sues Koko for money-laundering

The Anti-Corruption Commission (ACC) yesterday sued Arafat Rahman Koko for laundering money he had illegally taken from a Chinese company, Siemens and other sources in exchange for helping them get government contracts.

In the case, the ACC pinpoints Koko's dealings with China Harbour Engineering Company Ltd over a Tk 351 crore contract for constructing the New Mooring Container Terminal and Siemens over a Tk 239 crore contract for supplying and setting up equipments for Teletalk mobile phone company.



A few other persons also gave money to the youngest son of former prime minister Khaleda Zia in two of his five Singapore bank accounts detected by the ACC—four accounts with the United Overseas Bank and the other with the CIC Bank.

ACC Deputy Director Md Abu Sayeed lodged the case against Koko with Kafrul Police Station yesterday afternoon, stating that using his influence as the son of the then prime minister, Koko illegally earned the money between 2001 and 2006.

EC moves to get back its registration power

Decides to ask govt to put things right

The Election Commission (EC) has decided to ask the government to reinstate its power to take action against political parties breaching certain registration provisions.

It thinks the government did not mean to curtail the commission's authority to cancel a political party's registration for violating the provisions regarding nomination of parliamentary candidates and formation of associated bodies.

About the latest amendments to the electoral laws clipping the EC's wings, Election Commissioner Muhammed Sohul Hussain yesterday said, "We want to believe the government made those [changes] by mistake, and if so, we'll request them to put things right."

Talking to The Daily Star, he said the EC would write to the government on Chief Election Commissioner (CEC) ATM Shamsul Huda's return from abroad at the end of this month.
