Tk 444cr gobbled up during 2001-06 from water resources ministry, reveals TIB study

Around 800 acres of land in the Buriganga, Shitalakkhya, Karnaphuli, Dakatia, Betna and Surma rivers was grabbed by 1,200 encroachers violating the Wetland Protection Act, 2000.

KL's job-cut style a great injustice

50 civil society groups of South, South-east Asia decry premature termination of foreign workers

Fifty civil society groups from South and South-east Asia have said it would be a great injustice if Malaysian employers are allowed to prematurely terminate foreign workers' employment contracts and send them back home without adequate compen-

In a joint statement, they said foreign workers are unlikely to obtain refund from the agents if their visas are cancelled, reported Inter-Press Service, a Rome-based news agency, from Malaysian city Penangyesterday.

The statement comes following Malaysia's cancellation of 55,000 work visas to Bangladeshis, and application of the principle that employers terminate foreign workers before the locals. Bangladeshi workers pay around Tk 2 lakh to go to Malaysia for

Malaysian labour department recorded that in January this year, 4,325 workers were retrenched -- 2,153 of them local and 2,172 foreigners. The retrenchment was made in the wake of a decline in economic growth and export.

Malaysia has reportedly slashed its work permit approvals by over 70 percent this year.

Meanwhile, 100 to 150 Bangladeshi workers are returning from Malaysia every day for joblessness. Yesterday, 110 workers returned home without any compensation.

Journalists in South Asia face "severe risks" amid escalating violence in the region, the New York-based Committee to Protect Journalists (CPJ) said in a report released in the Philippines yesterday.

Attacks on media workers in Sri Lanka and Pakistan have increased and four other countries in the region -- Afghanistan, Nepal, Bangladesh and India -- also qualified for the CPJ's "impunity index."

The index, launched last year, lists countries where journalists are routinely killed or attacked and where governments have failed to solve the crimes.
