

EC still can cancel party registration

CEC claims commission's authority not curtailed in RPO changes

STAFF CORRESPONDENT

Chief Election Commissioner (CEC) ATM Shamsul Huda yesterday claimed that the Election Commission's (EC) authority to take action against registered political parties breaching certain registration provisions was not curtailed.

"Some people say that it has now been difficult for the commission to cancel registration. But it is not true," the CEC told reporters on EC Secretariat premises.

He made the remarks when his attention was drawn to the latest changes in (amendment) ordinance.

The bill passed in parliament on February 24 curtails the EC's power to cancel a political party's registration for tion if it had headquarters and offices in violating the provisions regarding nomination of parliamentary candidates and formation of associated bodies.

It is however true that the new law made harder the criteria for registration of a newly floated political party.

According to the new law, a new party seeking registration must have functional headquarters, offices in at least one third

BNP to dissolve dist bodies before council

Convening committees to get 2-month. time to form full committees

BNP will form convening committees in its organisational districts to prepare for councils planned to reorganise the party down to the grassroots level.

Before that, the party will dissolve the district committees that are long past their tenure. The decisions might come after the April 2 byelections, said sources close to the highcommand.

The convening committees will be tasked with organising councils to elect full committees within two months since their formation.

committees, the party will focus on holding national council as per the Election Commission's registration guidelines.

At talks with the EC before the ninth parliamentary polls, the political parties agreed to hold councils within six months after the first sitting of parliament, and ratify the provisional changes they made to their constitutions to get registered.

This leaves them time till July 25.

"We hope we'll be able to reorganise the party in line with the Representation of the People Order. We might need some more time though to complete everything properly," BNP standing committee member Lt Gen (retd) Mahbubur Rahman yesterday told The Daily Star

Dhaka-Delhi inland water transit, trade protocol renewed

Minister says govt to build deep-sea port

Bangladesh and India renewed the protocol on Inland Water Transit and Trade to enhance trade between the two countries through waterways.

The two-year protocol was signed yesterday after a two-day negotiation between delegations of the countries. The present protocol was supposed to be over on March 31 and it is under the bilateral trade agreement of the two countries. Though the delegations discussed several issues, no change

was made in the renewed protocol. This protocol was signed in 1972 and renewed in every two years.

After the formal signing of the renewal agreement, both parties talked to the media and said that no major issues were kept unsettled.

Meanwhile, Shipping Minister Dr Afsarul Amin yesterday said the government is determined to move ahead with the deep-sea port project at Sonadia in southern Chittagong, one of the pre-election pledges of the present government.

Rights bodies slam KL over job-cut policy

92 more workers back from abroad

Migrants' rights bodies yesterday slammed the arbitrary retrenchment of Bangladeshi workers in Malaysia, saying such policies go against international labour laws and humanity.

They demanded that the government immediately form a inter-ministerial taskforce to ensure that these 'cheated' workers are reinstated in their jobs where possible or get at least some form of compensation.

They also stressed the need for a database being maintained of the returnee workers so that the government can help in their rehabili-

Meanwhile, 92 workers returned from financial crisis. abroad yesterday.

"The situation has created a huge frustration among workers and their families," said Sheepa Hafiza, director (training) of Gender Justice and Diversity and Advocacy, Brac at a press conference on the issue at the Dhaka Reporters Unity in the capital.

Two fishing cats beaten to death


