BNP stages walkout

The BNP-led opposition lawmakers yesterday walked out of the House in protest against expunging of speeches of its newly elected women lawmakers in the reserved seats in parliament.

The EC Secretariat on Thursday and yesterday sent letters to political parties reminding them of the legal provision following their lukewarm response to submission of the report within the March 31 deadline.

Only four political parties -- Gono Forum, Jatiya Gonotantrik Party, Jatiya Party (Manju) and Islami Oikya Jote -- submitted poll expenditure reports to the EC till yesterday, EC Secretariat sources said.

The EC on January 27 sent letters to the 38 political parties that contested the December 29 parliamentary polls asking them to submit expenditure reports on or before March 31, as the election results of 299 constituencies were published in official gazette on January 1.

A fervent appeal to the Honorable Prime Minister From Bangladesh Shipping Agents Association

The shipping agency business has prevailed in Bangladesh for several decades catering to the needs of foreign vessels in port of Chittagong and Mongla and handling the major portion of export/import. Skilled and professional Bangladeshi entrepreneurs have been making significant contribution in earning foreign exchange worth several hundred crore taka and also ensuring stable employment to thousands of workers through more than 300 (three hundred) shipping agency houses in Bangladesh.

Sad but true, some vested quarters have ignored the national interest and managed to issue shipping agency license to some foreign shipping companies to do trading business in Bangladesh without any investment. This has threatened the very existence of this well organized business which the Bangladeshis have been doing through ages and within the provisions of existing rule. This is causing serious concern to us especially at a time when our government is trying to cope up with the effect of global economic melt down threatening multiple sectors.

Our association appealed to the relevant wing of the government to stop issuing shipping agency license to foreign shipping companies and also prayed for cancellation of the licenses already issued beyond the purview of the law. The relevant Government authority suspended the license of one foreign shipping company and in response, the foreign shipping company took the shelter of the law and obtained a stay order on the decision of NBR. The stay order eventually was not tenable and was vacated in the highest Count of the country in favour of the government which reflected the greater national interest of the country as against the interest of the foreign shipping company.

Some vested quarters, without any regard for the law and interest of the country, is doing all it can to work in favour of the foreign shipping companies.

Under the circumstances, being compelled, we make an appeal to our beloved leader, the Prime Minister to kindly intervene so that the law is not violated and licenses are not issued to the foreign shipping companies to the detriment of the national interest.

Certain agencies' blanket authority

to refuse info curtailed

The House yesterday passed the much-awaited bill to continue people's right to information, incorporating a parliamentary body's recommendation to limit a few organisations' absolute authority to refuse to divulge information.

As per the provisions of the bill, all organisations registered under the law of the land will be bound to provide citizens with information on matters of public interests.

Organisations that enjoy legal coverage to keep some information undisclosed will have to take permission of the information commission to deny information sought, the parliamentary standing committee on information ministry recommended in its scrutiny report on the bill.
