8 killed in attack on US nursing home

dead eight people, many elderly and infirm patients, in a North Carolina nursing home Sunday, authorities said, announcing that the shooter was in custody.

They identified the alleged gunman as 45-year-old Robert Stewart, but shed no light on why he went on a shooting spree at the Pine Lake nursing home in Carthage, North Carolina, a village of just 2,000 people.

"This morning a lone gunman came to the Pine Lake nursing homein Carthage and as a result of his actions today, he is facing eight counts of first degree murder," said Maureen Krueger, the Moore county district attornev.

She said the victims included a 98-year-old patient, four victims in their 80s, two in their 70s, and a nurse.

The killings stunned tiny south central North Carolina theworst in the state's history. county. Officials said at a press conference that the town has a police force of 18, just two of whom were on duty at the time of theviolence.

Carthage police chief Chris McKenzie said he had never encountered anything like in 20 vears as a police officer.

"I don't know that the emotion has entirely set in," McKenzie said. "This is a small community built on faith and faith will get us through."

He said the Red Cross and the county department of social services and mental health were providing help to families of the victims and the staff of the nursing home, and the town's First Baptist Church had opened its doors to those affected by the tragedy.

The first calls to the police emergency line came in at 10:03 am reporting that a shooting was underway at Pine Lake, a 90-bed rehabilitation, nursing and RifleAssociation.

Krueger said police A heavily-armed gunman shot responded and one of the officers, Justin Garner, acted "in nothing short of a heroic way today. But for his actions we certainly could have had a worse tragedy."

At least six people were taken to the First Health Moore Regional Hospital, where two died, a hospital spokeswoman said. Two of the injured were treated and released, two others were hospitalised, said Emily Sloan:

The carnage is the latest to rock small town America, which often has borne the brunt of outbursts of gun violence, but where many inhabitants fiercely advocate the right to own and carryguns.

Earlier this month, a 28-yearold out of work man killed 10 people, including his mother and a toddler, in a shooting rampage through two counties Carthage, the seat of a bucolic in the southern state of Alabama,

In December, a man dressed in a Santa suit opened fire at a Christmas party being given by his ex-wife in Covina, California, killing nine people before shootinghimself.

In October, an ex-convict opened fire with an assault rifle at a man and two children who had come to trick or treat at his home in Sumter, South Carolina on Halloween. A 12-year-old boy died of his wounds in that inci-

In September, a mentally ill man shot eight people, killing six, in Alger, Washington a month after being released from prison.

The United Arab Emirates (UAE) is eager to invest in hotel, tourism, oil and telecommuni cations sectors in Bangladesh, said State Minister for Foreign Affairs Hasan Mahmud yester

He disclosed the fact during a press briefing at the ministry after his visit to the UAE and Genevalastweek.

The state minister said he held an extensive discussion with the UAE Labour Minister Saqr Ghobash Saeed Ghobash and asked him for special care to Bangladeshi workers.

The gulf nation assured special heed to Bangladeshi workers to make sure they survive the economic meltdown, he added.

Hasan Mahmud requested the UAE leaders to set up a hospital and a nursing institute on the land in Chittagong that was offered to UAE former ruler Sheikh Zayed bin Sultan al-Nahyan as a token of friendship.

Presently, the oil-rich UAE investment in Bangladesh is \$2.5 billion, he said.

"I requested him to ease residency visa transfer system, which is somewhat clumsy, and introduce online visa system to prevent forgery," he told news-

As Mahmud requested the UAE labour minister to ensure workers' wages in due time, the latter said they would introduce a system by the end of the year so that all workers get wages through banks and employers cannot make any deductions.

The UAE is the second largest labour market for Bangladesh after Saudi Arabia. Around seven lakh workers send around \$1 billion remittance yearly from UAE.

The UAE state minister for foreign affairs said apart from labour issues, Bangladesh and UAE should diversify relations to work together in international arena, said Mahmud.

"It means they want collaboration in the Palestine issue and producing green energy, Hasan Mahmud elaborated.

The ministers also shared views on combating terrorism.

officials had implicated a number of innocent people in the case, filed in connection with the grenade attack on an Awami League rally on August 21, 2004, to hide facts and to let the actual criminals get away.

He said they destroyed evidence and did not record the confessional statements of the culprits, including outlawed Islamist militant outfit Harkatul Jihad al Islami (Huji) leader Mufti Hannan, who admitted his involvement.

The complainant said the officials forced petty criminal Joj Miah and two others to confess before a magistrate by torturing them, threatening them and buying them with money.

Talking to The Daily Star over phone yesterday, accused former CID official Abdur Rashid refuted the allegations and said, "I did not force or threaten anybody into confessing before the court."

"There were several authorities to justify that the accused persons were involved in the attack before they made confessional statements," said Abdur Rashid, adding, "It is not true that we tried to misdirect the case as we did not submit the charge sheet.'

ASP Fazlul Kabir told The Daily Star, "Case-52 [filed Sunday night] was filed after investigation and following other legal procedures, including taking the opinion of the public prosecutor."

Talking to The Daily Star, Paltan Police Station Officer-incharge Mohammad Majibar Rahman said the case was forwarded to the court in compliance with standard proce-

According to the case statement, the CID took charge of the grenade attack case investigation on August 23, 2004, two days after the attack. The CID appointed ASP Abdur Rashid as the investigation officer and SS Ruhul Amin was made supervi-

ASP Rashid arrested 20 people and forced Joj Miah, Abul Hasem Rana and Shafiqul Islam to confess before magistrates under Section-164 of the Criminal Procedure Code (CrPC) on June 26, December 12 and December 17 of 2005, the case statement read.

After Abdur Rashid retired, Munshi Atiqur Rahman was appointed investigation officer of the grenade attack case on December 24, 2005.

In the meantime, CID had arrested Huji leader Mufti Hannan in connection with the Ramna Batamul blast case. He is also accused in several other cases filed in connection with militancy.

During CID interrogation, Hannan confessed to his involvement in the grenade attack and disclosed names of 27 others who were directly and indirectly involved in the planning and execution of the attack on the Awami League (AL) rally.

The names include former BNP deputy minister Abdus Salam Pintu.

Through multiple investigations, the BNP-led alliance government tried to establish that the AL itself killed its own leaders and activists to tarnish the image of the BNP-led gov-

They also tried to prove that "foreign enemies" instigated the carnage and some listed criminals absconding in India

had executed the attack. A total of 24 people were killed and over 300 were maimed in the attack that was aimed to assassinate the then leader of the opposition and present Prime Minister Sheikh Hasina

Fifty months after the attack, a Dhaka court on October 29, 2008, framed charges against 22 people, including former BNP deputy minister Abdus Salam

Rest of the accused are leaders and operatives of Huji.

Eleven days after the attack, the then prime minister Khaleda Zia blamed the AL for the attack.

Interpol's detailed report was attached to the charge sheet and submitted to the government while the FBI never submitted a report even though they collected pieces of evidence for running tests. The BNP-led government's stance subsequently influ-

enced the then investigators to weave a story involving Mokhlesur Rahman, a wardlevel AL leader and former ward councillor of Moghbazar in the capital. The investigators also tried

to concoct another story through a dubious "confessional statement" made by Joj Miah, who named Mokhlesur as one of the planners of the grenade attack.

Joj Miah turned out to be a creation of the investigators when his sister revealed that the CID had been paying his family Tk 2,500 a month for upkeep since his arrest.

Joj and two others provided nearly identical and weakly woven statements, which were widely discredited by the media.

Apart from Mokhlesur and Joj, 18 others were arrested and were allegedly tortured. A Dhaka court later ordered their release saying the charges brought against them by the erstwhile investigators were baseless.

Last year, several serving and retired investigators involved at different stages of the probe, told The Daily Star that the masterminds of the attack remain undetected even though charges had been pressed in the two cases--one for the killings and one filed under Explosive Substances Act.

Of them, two bills were passed amending the Desa act and Biman corporation ordinance for continuation of
