TRAWLER CAPSIZE Six more bodies recovered

With the recovery of six more bodies yesterday, the death toll from Tuesday's trawler capsize in the Sugandha under Baruganj upazila of Barisal rose to nine.

The dead are Sumi Akter, 26, wife of Alamgir Hossain Tulu and their son Sejan,5, of Bakhsirchar, Rina Begum, 35, wife of Selim Howladar, Chandravan,35, wife of Md Ershad of Khanpura, Runu Begum, 40, wife of UP member Ashraf Ali, Salema Khatun, 50, wife of Khadem Ali Gharami of Khudrakati, Rabeya, 8, daughter of Abdur Razzakl Molla of Khudrakati under | Molla of Khudrakati under Babuganj upazila of Barisal, Mamataj Beguim, 27, wife of Abdur Razzak and Jyotsna Khudna FFs making Begum, 30, of Kawnia

The trawler with about 25 on board was caught in a storm and sank in the river near list of razakars and sank in the river near Rahmatpur under Babuganj upazila. Half of the passengers managed to swam ashore while the rest went missing.

Divers and fire Brigade personnel recovered three bodies on Tuesday night and six bodies yesterday. The rest four or five passengers are still missing.

The sunken trawler was salvaged yesterday afternoon, but no body was found inside.

4 killed in 3 districts

Four people were killed in separate incidents in Kushtia, Chuadanga and Meherpur on Monday and Tuesday.

Farmer Alfaz Hossain, 47, was killed in a bomb attack at Bagadi village while rival party men slaughtered Atiar Rahman, 39, a top cadre of the outlawed Lal Pataka, at Bhangbaria in Alamdanga upazila of Chuadanga Tuesday.

According to police, a gang of criminals stormed into the house of Alfaz at about 9.30:pm and hurled a bomb He died on the spot.

Later, an unknown caller claiming to be a cadre of the outlawed Lal Pataka said he killed Alfaz as he refused to pay the extortion money they demanded several days ago.

In another incident, rival party men slaughtered out lawed Lal Pataka's top cadre Atiar.

According to police, a gang of 10 went to the house of Atiar at Sahapur village in Gangni upazila in Meherpur district at about 10:30 pm.

The gang picked up Atiar on gunpoint and took him to Bhangbaria field and killed him there.

In Kushtia, unknown criminals strangled a young woman after rape at village Bhadalia on Monday night, while stepbrothers murdered a young man at Asannagar in Sadar upazila on Tuesday. Locals said, cadres of out-

lawed Gono Mukti Fouz (GMF) led by Sabdul picked up the girl from unknown place and confined at his house for several days. They gang raped her and later strangled her and threw the body to a nearby paddy field.

Step brothers led by Karam Ali chopped Nazim Uddin,25, on Tuesday morning following an altercation over a disputed land. Nazim died on the spot. Police recovered the body

and arrested Karam and his two sons Anis and Alamgir.

Freedom fighter Sukurullah committed suicide Monday night as he had no means to bear the expenses of his treat-

Hailing from Razarpath Danga cluster village under Sadar upazila in Panchagarh, Sukurullah, 70, killed himself by hanging from a tree near his house.

Wife Fatema Begum said Sukurullah had been suffering from various ailments for long. As he could not bear pain anymore he committed suicide, she said. Sukurullah used to get Tk 900 per month as freedom fighter's allowance, Fatema said, adding it was not enough for family expenditure.

Sukurullah was a rickshawpuller. But after growing old he was unable to continue it. He has two sons and a daughter. His sons are poor hotel boys who could not arrange the treatment money.

A few days ago, he was admitted to Panchagarh Sadar Hospital. But seeing no improvement he left the hospital.

Panchagarh Upazila Unit Commander of Muktijaddha Sangsad Abdus Sobhan said Sukurullah had been suffering from various health complications for a long time. But he never sought money from anybody for his treatment.

A schoolteacher risked his life to save a girl student who was about to commit suicide under a running train on the Teesta Bridge.

The incident took place at about 5:30 pm on Tuesday when a local train entered the bridge from Kaunia.

Earlier, gatemen on both ends of the bridge closed the gates at about 5:20 pm so that no vehicle can enter it.

But a girl student of class IX of Kaunia High School went to the middle of the bridge evading eyes of gatemen. She stood there like a statue shutting her eyes with two hands. Several hundred people who witnessed the scene shouted at the girl asking her to leave the railway track.

As the train was nearing fast, Akbar Ali, a religious teacher of Kaunia High School, who was waiting to cross the bridge, saw the girl and immediately rushed to her and pushed her out of the track just four seconds before the possible mishap.

Later, he took the girl to his Kaunia house and contacted her parents who admitted that their daughter had love affair with someone whom they disliked.
