Process of war crime trial kicks off Apr 8

UN experts to visit shortly to assist in investigation

The process of trying war criminals is expected to begin on April 8 with the appointment of an investigation officer and a public prosecutor.

Meanwhile, Bangladesh has accepted a UN offer of sending a team of war crime experts to help Bangladesh try those who the meeting. were involved in various war crimes during the Liberation War of 1971.

Law ministry officials said the group of UN specialists, having experience in dealing with war crimes that had occurred in different nations, might visit Dhaka shortly.

Bangladesh Renata Lok Dessallien put forward the offer at a meeting with Law UN's.

Minister Shafique Ahmed at his ministry. Home Minister Sahara Khatun was also present at the meeting.

"We have offered Bangladesh to bring here specialists, who deal with the war crime issues, so that the trial process of 1971 war criminals meets international standards," Renata told reporters after

She said mistakes have been made in trials of war crimes earlier in many countries. "The experts will share their experiences here in Bangladesh to avoid the mistakes," she added terming the process very complex and delicate.

Renata reiterated the UN's coopera-UN Resident Coordinator in tion in holding the trial but said the trial would be of Bangladesh's own, not the thetrial.

State Minister for Law Quamrul Islam said steps have already been taken so that suspects of war crimes cannot flee the country. He would not say who are on the list of suspects.

An inter-ministerial meeting, sched uled for Wednesday at the home ministry, would discuss the probe and trial issues for the second time since March 25. The meeting may also appoint a public prosecutor.

Once an investigation officer is appointment, law ministry officials said a large team would be formed to initiate investigation into the genocide that took place during the Liberation War. The government has also passed a resolution in parliament paving the way for holding

Thanks-giving motion to be Daylight saving time likely from June

Proposal to advance time by an hour as a measure to save electricity

The government is likely to forward Bangladesh Standard Time by one hour from June under a proposed Daylight Saving Time (DST) plan to manage the power crisis.

The Power Division of the Ministry of Power, Energy and Mineral Resources yesterday discussed the issue with other ministries at a meeting. It also asked all ministries to send their views on the proposal by Thursday.

"We have requested all ministries concerned to let us know their views on the matter by Thursday," State Minister for Power Shamsul Haque Tuku told reporters after the meeting at his ministry.

If the proposal is approved, all will have to forward their clocks by one hour from June because HSC examinations begins on April 16

Thirty deported workers from Malaysia yesterday staged a sit-in at the Zia International Airport, demanding compensation from the government for their being cheated and the huge amount of money they spent for preparing legal papers and getting jobs.

Fifty-three of us went to Malaysia through recruiting agency Tangail Overseas, butit could not give us work permit although it took a lot of money from us," said Rubel, one of the deported workers.

Workers in Malaysia denied promised salary, food, accommodation

PORIMOL PALMA, back from Malaysia

The employment was supposed to be permanent and the monthly wages were promised to be 600 Ringgits (RM). But they were employed for only 22 days in the first three months and paid just RM 200.

"Sometimes we could manage food with that money, sometimes we starved. When there was no

work we were kept in godowns together,' Moniruzzaman told The Daily Star sitting at a makeshift restaurant in front of Bangladesh High Commission in Kuala Lumpur.

Moniruzzaman, 25, of Jhenidah, is one of 21 workers who went to Malaysia in September last year through recruiting agencies.

"Malaysian and Bangladeshi agents take away large portions of our wages and then sell us to another agent," he was describing how Bangladeshi workers fell into a vicious trap of modern day slavery as outsourcing companies,

brokers and errant employers have used labour supply for a money-making scheme. The outsourcing companies even keep the passports of the workers and demand money in return for those.

These fortune seekers followed all proce-

dures required to go to their "dreamland" and spent huge amounts of money but now they can neither earn enough to support their families back home nor can they survive in

Malaysia themselves. These workers remained stranded in Kuala Lumpur airport for four days before their agent

Joya Bala took them to Johor Baru to sell them to at least three other agents. Another worker named Zahirul Islam said,

"With expired work permits or without any job, we are living haphazardly--under a bridge maybe, but then, police raid the place."

Plan to extend primary education up to class-8

Education policy being formulated in light of Khuda Commission

The government plans to modernise the primary education system by extending it up to class VIII and introducing a final examination at the end of this level.

The process of the modernisation of primary education will start after formulation of National Education Policy in line with the recommendations of the Qudrat-e-Khuda Education Commission-1974, education ministry officials said.

The policy formulation will be completed within a couple of months.

Besides, a 15-member national textbook expert committee led by Dhaka University Teachers' Association former general secretary Prof Akhtaruzzaman has already been formed

to update syllabus, curriculum and contents of textbooks of primary level.

The committee will consult with teachers and experts and prepare recommendations within next one month, primary and mass education ministry sources said.

The primary and mass education ministry is now very much concerned about the quality of education at the primary level and also planning to update the system.

A recently published survey report of directorate of primary education (DPE) revealed that around 70 per cent of students who completed five-year primary education are unable to read, write or calculate properly.





Heated debate in JS over rice price



The debate kept the House quite heated for sometime defying the air conditioning.


