But the defendant No. 1, Court of Wards Dhaka Nowab Estate, filed Misce Case No. 36 of 2005 challenging the said decree dated 30.06.1986 which is till now pending in the 3rd Court of Joint District Judge, Dhaka.
- So, the alleged possessors have no right, title and interest over the schedule land.
