## Govt to amend War crime trial process gets final shape

Appointment of investigating agency in 3 days, prosecutors in 2 weeks, decides govt

STAFF CORRESPONDENT

The government will assign an investigation agency within three days and prosecutors in 10 to 15 days to probe the genocide committed by the collaborators of the Pakistani occupation forces during the 1971 Liberation War, said Law Minister Shafique Ahmed yesterday.

"A tribunal will also be formed later to try the said. war criminals in compliance with the International Crimes (Tribunal) Act, 1973," he said after an inter-ministerial meeting at the : home ministry. .

Some three million civilians were killed by

the Pakistani occupation forces and their collaborators in 1971, while about 200,000 women were violated, and thousands of houses were torched and plundered.

Briefing journalists at the law ministry later, he said they were yet to decide on who would be appointed as the investigation officer.

"We have just started the process," Shafique

innocent person is victimised. "We want to bring the real culprits to
